<u>The ABC Bylaws, Article X, Section 4 (xii)</u>, provides that the Board of General Ministries shall: elect the General Secretary; and evaluate the performance of the Office of the General Secretary biennially.

The ABC Bylaws, Article XV, Section 1 also states: Upon nomination by the ABCUSA Nominating Committee (which, for purposes of this nomination, shall include one additional individual chosen by the National Boards), the General Secretary shall be elected by the Board of General Ministries for a term of four (4) years (or such shorter term as the Board of General Ministries may specify) and may thereafter be reelected to such office by the Board of General Ministries for any number of additional terms.
