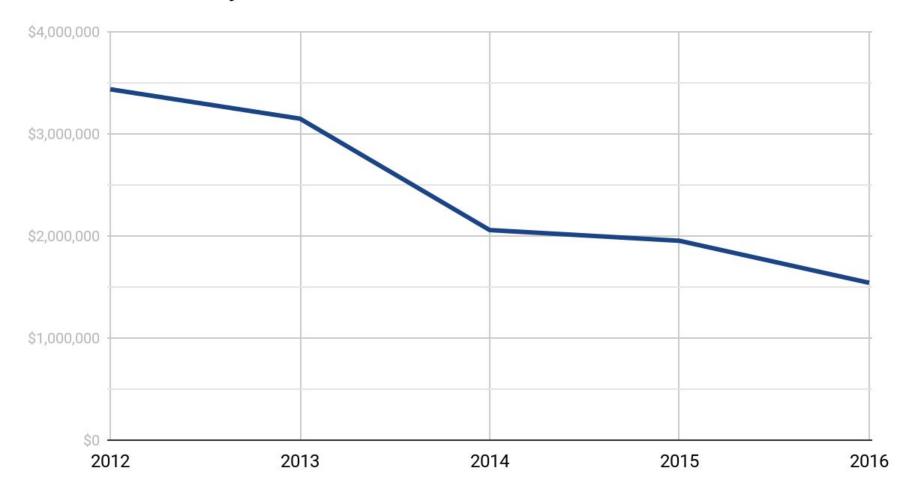

- Some significant changes from 2015:
 - Investment gains up \$1.7 million
 - Biennial expense down \$777,000
 - G & A down \$119,000
 - Representative Process down \$85,000
 - Ecumenical relations down \$73,000

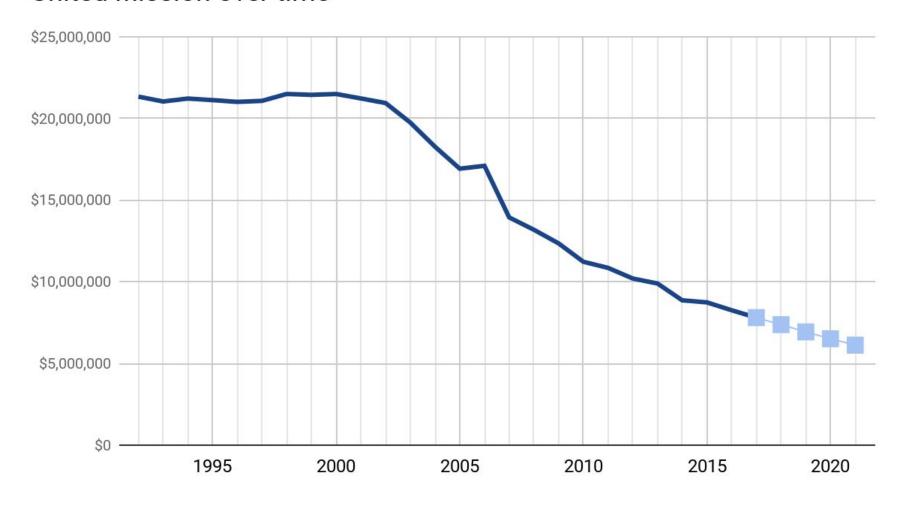
Year-to-date financials (4/30/17)

- All amounts exclude the biennial
 - Biennial financial results are incomplete
- Revenue is down \$248,000 from a year ago
- Revenue is 14% less than budget

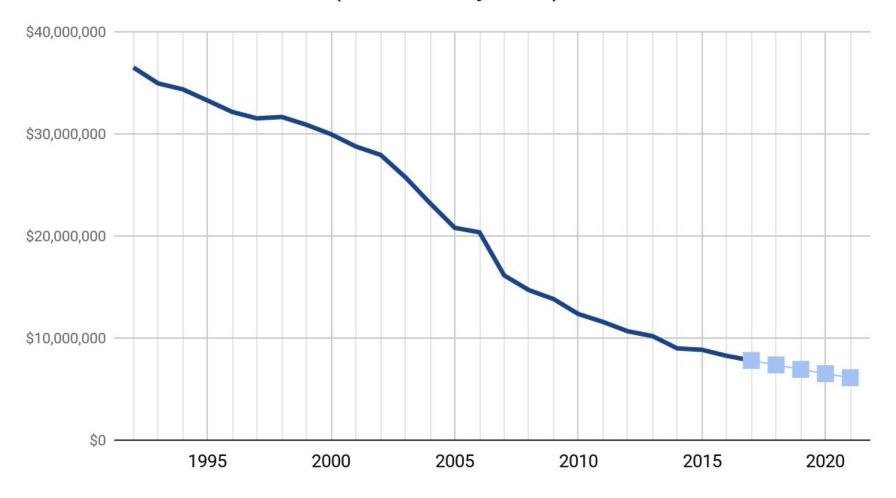
Year-to-date financials (4/30/17)

- Expenses are \$171,000 less than a year ago
- Expenses are 7% under budget
- Net loss of \$58,000, compared to
 - budgeted gain of \$31,000
 - year ago net gain of \$19,000

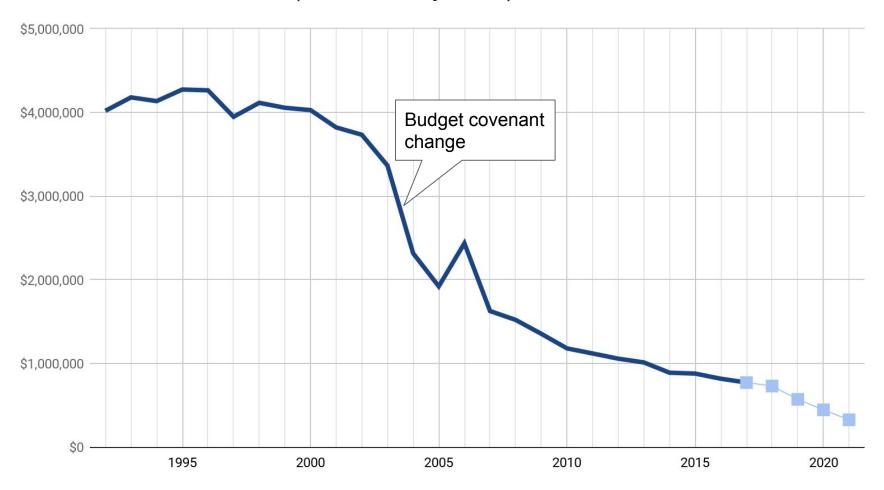
United Mission over time

Need new revenue sources

- Fee for service
 - Partners less interested in shared services
 - Loss of income from building operations
- Redevelopment of Mission Center property
 - Unlikely to cover the drop in United Mission
 - Could take several years to reach peak earnings
- Endowment emphasis
- New initiatives
 - "Mission creep"
 - Awareness of boundaries with partners
