### **Review of Mission Initiative Fund grants**

The committee considered two requests for funding from the Mission Initiative Fund.

The first request was for the continuation of funding for the ABC Creation Justice Network. Funding was granted for the second year. However, the group's request that the previously budgeted stipends be directed instead to a cooperating non-profit (Creation Justice Ministries) was denied. In addition, unspent funds from the first year of the project may not be rolled forward into the second year, in accordance with the Mission Initiative Fund guidelines.

The second request was for funding for a Latino Initiative program at American Baptist Seminary of the West. Funding was approved with great regard expressed for the quality of the proposal and the potential benefit to the entire denomination.
