- 3. Once the PROFILE FORM is received, we will send the local church and region their RECOMMENDATION FORMS for the Candidate.
- 4. Once all forms are completed and received the information will be reviewed by the ABC Nominating Committee.
- 5. The current pool of candidates will be considered in November 2010. Candidate <u>PROFILE FORMS received after October 8, 2010 cannot be considered</u> due to the need for time to secure RECOMMENDATION FORMS from churches and regions. <u>The earlier the PROFILE FORMS are received the better</u>.
- 6. Nationally Nominated Representative (NNR) Nominees will be elected in their regions during 2011 and take office January 1, 2012.
- 7. Please note that for the 2012-2013 Biennium the <u>category for President is</u> Laywoman and the category for Vice President is Clergyman.
- 8. Statements of Concern Committee members take office following the June 2011 Biennial Meeting.

#### ABC REPRESENTATIVES, OFFICERS, STATEMENTS OF CONCERN COMMITTEE

#### QUALIFICATIONS AND COMMITMENTS:

- 1. Commitment to Jesus Christ and the whole mission of the church to evangelize, educate and encourage.
- 2. Understanding of and respect for the purpose, history, diversity and traditions of the ABCUSA and its ministries.
- 3. Demonstrate active membership in a contributing ABCUSA church and region and an individual commitment to support its missions financially.
- 4. Regular participation and involvement in board and committee meetings and willingness to contribute your unique skills and abilities.
- 5. The ability to listen, negotiate and reconcile which enables us to discern the mind of Christ and build up this community of faith.
- 6. The ability to lead as well as serve, to envision the future as well as plan for it.
- 7. The desire to study and grow in your Christian faith and your understanding of the work of Christ in our world today.
- 8. The ability to communicate to others the goals, programs and ministries of the ABCUSA.
- 9. Time Commitment: a) Officers travel and speaking on behalf of the denomination, plus attending General Board and related committee meetings; b) Statements of Concern Committee two days of meetings twice a year (fall and spring), meeting two days prior to the Biennial and during the Biennial meeting; c) Representatives five days once a year; two to three days per year for communication, interpretation and advocacy in your region; quarterly meetings of your region; other time as mutually agreed on for extra committee meetings.

#### FUNCTIONS OF A GENERAL BOARD REPRESENTATIVE:

- Active Learning and Policy Making. You will receive reports from staff, proposals for budgets, readings for
  resolutions, declarations, policy statements and letters from your constituency. It is vital that you take
  responsibility for your own education on these matters so that the decisions we make are responsible and
  informed. The General Board is the primary policy-making body of the ABCUSA. This includes electing persons
  to offices and committees, voting on budgets and policies and program direction.
- 2. Communication and Public Relations. It is our task to be interpreters and advocates for the work of the denomination as a whole. Each of us has particular spheres of activity (church, region and other bodies) in which we can exercise this role. We represent the denomination in those spheres. We are also channels for communication from our constituency to denominational leadership. This involves an exercise of judgment: it is important that widely held views and other significant elements of opinion be reported; but every individual letter a Representative receives cannot be afforded General Board time.
- 3. <u>Evaluation and Oversight</u>. General Board Representatives are responsible for holding denominational staff accountable to our policies and program direction. All evaluation should be done candidly, constructively and directly.
- 4. Affirmation and Encouragement. Staff members and missionaries work on behalf of us. It is our role to encourage and pray for each of these, including the work of the local church. Words of appreciation, questions for clarification, suggestions and resources are all appropriate ways to fulfill this function. Your active participation in committee meetings also will provide encouragement.
- 5. <u>Envisioning and Creative Input</u>. We are a "think tank" to envision the future God has planned for us. We are more than the sum of our parts as we energize each other with ideas, reflections and visions. In this way, the Holy Spirit can work through our diversity to bring a unity of mission. This in turn determines the direction of our denomination and each of its ministries.
- 6. <u>Financial Stewardship</u>. With membership on the Board, each person has responsibility to contribute personally and to aid in the task of raising mission dollars. Such a responsibility comes with membership on any board of any organization. It is denominational policy to expect that Representatives tithe and promote tithing in ABC churches.
