

ABCUSA MATTHEW 25 GRANT APPLICATION



A generous donor has given a sum of money through American Baptist Churches USA to be used for programs that address “housing, feeding, education and health with regard to the less fortunate.” A panel will select recipients for grants of up to \$5,000 largely based on the degree to which the funds will be used to *directly assist persons in poverty*. Ministries must be in a direct relationship with American Baptist Churches USA to be eligible to apply, and only one application per church or Region will be considered per 12 month period. Grant funds may not be used to fund staff positions or for capital improvements to facilities. Grant awards will be sent to the ABC church or Region, checks will not be made payable to an individual or ministry.

3. Specifically, how do we anticipate using the funds requested?

Camp is a great time for integrating spiritual, practical and educational components together. The registration and 4 1/2 day meal preparations by the Camp Staff are absorbed by grant funding. In order for the children to participate in the Camp Activities, the projected cost in item 2a is for *one time*. For example, if a child desired to swim more than once during the week, it will be an additional cost. We intend to “raise” the standard of our camp by the implementation of the “affordable and nutritious food project.” This involves the purchase of at least 5 Nutra Bullets where we will offer hands on training. At the end of the camp, three- five children (families) will be awarded the actual item. BBI will be set up assessment tools (*observational and informational*) wherein we will track 3-5 families for a period of 6 months. In that time period, our expectations will be to document reports of nutritional health, minimal sicknesses, and minimal trips to the doctors etc. because of “better heath.”

4. How will the funds assist individuals battling poverty and its effects?

Glancing at the national numbers, 16 million children in the United States are living below the poverty level. We know that “*affordable and nutritious food is difficult for them to obtain.*” This represents a “*food desert.*” We are addressing this issue through camp and on a lower numerical scale. It is our intention to *reach* them and *raise* their *awareness* developing this new *incentive* in an effort to provide a healthy *solution* that can be shared in the home.
