## First Baptist Church of Omaha Matthew 25 Grant Proposal Community Meal Program

First Baptist Church of Omaha (FBCO) is located in a neighborhood that is starting to undergo renovation. A new apartment building recently went up across the street, old buildings are being torn down with plans to be rebuilt, and others are already in the process of being rebuilt. In the shadows of these modern apartment buildings, people continue to live in poverty. As old buildings are being torn down, people are being forced to leave their homes and some have no place to live. Renovation many times comes with a price. For people living in poverty, it is a life changing event that many have a difficult time recovering from. For FBCO, renovation can be both exciting and heartbreaking. It is exciting with the prospect of modern buildings, new members, new surroundings, and new souls to win for Christ. It is heartbreaking with the thought of our neighbors who are living in poverty, many without homes. Their homes might not have been great but they provided shelter from the weather and a place to sleep. Our congregation firmly believes God continues to have a mission and a purpose for FBCO and we are committed to sharing God's Word and living the gospel here in Midtown Omaha. We feel this is exemplified in our Vision Portfolio which is provided in Attachment A.

The demographics of our neighborhood are slowly starting to change but poverty, hunger, and desperation are still very widespread. The US Census Bureau's 2014 American Community Survey shows 46.3% of the people living in our neighborhood were living below the poverty level. Please see Attachment C.

We currently have an outreach program called the Community Meal. A free meal is served on Saturdays for the people of our neighborhood and anyone else who needs a meal. The meal is promoted on our marquee so that people who pass by know they can get a hot meal on Saturdays. The Community Meal is held at FBCO and hosted by a different church or organization each week. There are churches and organizations that are located within the neighborhood and some that come from other areas. A free food pantry was also provided on Saturdays for our guests for a while. A couple of months ago, we ran into some challenges with transporting the food on Saturdays and there was no place to store the food so the food pantry is no longer available. A new program was implemented on a trial basis where hygiene items were distributed once a month. The hygiene items include toilet paper, toothpaste, toothbrushes, deodorant, soap, shampoo, and other necessities. Most people take these items for granted but for many of our guests, these items are luxuries they cannot afford. The people were very receptive to the new program which was funded by personal donations. Since the trial worked well, we would like to start the program on a permanent basis.

The attendance for the Community Meal is usually around 75 to 100 people for the first couple of weeks during the month and it increases the last couple of weeks. This year one of our goals is to have a heightened awareness of the Community Meal in the neighborhood which will hopefully result in an increase in attendance. Our plan is to canvas the neighborhood in the fall and hand out flyers inviting people to the Community Meal. The guests not only receive a free meal but they are also able to relax in a safe environment that is protected from the weather. The volunteers are also good about visiting with the guests and some of our guests look forward to those conversations each week.

We would like to provide a special meal the week before Christmas. Many of our guests don't have families so we would like to celebrate Christmas with them. It would be held at the same time as the Community Meal. We would also like to hand out a \$5.00 restaurant gift card or food voucher to a local grocery store to each guest as a gift. This would provide one additional meal for them during the holidays which is a difficult time for people who are living in poverty. It is especially heartbreaking for families with children.

The funds from the Matthew 25 grant would be used to provide hygiene items once a month, four meals including a special Christmas meal, and 225 \$5.00 gift cards to a local restaurant or vouchers to a local grocery store. Please see Attachment B for the budget for the Community Meal Program.

God is working miracles every day in our neighborhood and FBCO is blessed to be a part of His Ministry in this community. We want to show our neighbors they are treasured human beings who are dearly loved by God.
