Grant funds may not be used to fund staff positions, rainy day fund, church benevolent fund, or for capital improvements to facilities. Grant awards will be sent to the ABC church or Region that is applying for the grant; checks will not be made payable to an individual or ministry.

Our location in downtown Tacoma provides us with the unique opportunity to minister to and provide services for a diverse community of people. Our central location also makes us easily accessible to those who are in need of the basic necessities of food, shelter, and clothing within our community. Guests of our Community Breakfast program are hungry for sustenance and community. With a team of volunteers from our church and other churches in the area such as Peninsula Baptist and Grace Baptist, a free, hearty, and hot breakfast is served along with fellowship, conversation, and even songs led by one of the guests on occasion. During the

colder months, we have often also provided donated blankets and socks to our guests. Throughout the year, volunteer groups collect items such as hygiene supplies, etc. that are also given out. Many of the breakfast guests also seek spiritual nourishment and attend our church's worship services as well.

The Community Breakfast Program meets a vital need in our community. Since 1995, the amount of homeless and low income in Tacoma has increased, causing even more strain on local social service agencies. As a church, providing this one meal a week and giving people access to resources helps us to contribute to alleviating those in poverty in our neighborhoods. Over the years, a community of volunteers and guests has developed and many would call it a family. This program provides more than just food. Not only are our community partnerships providing resources to help alleviate poverty, but it gives volunteers a purpose beyond themselves and guests a dignity and fellowship of friends to come home to each week.

Ministry Description:

For over 21 years, our Community Breakfast program has provided sustenance and fellowship to hundreds of guests on a weekly basis. We open our doors every Sunday morning to approximately 250+ people including adult men and women as well as many young adults and children. For those that have experienced chronic homelessness, for the recently homeless, and for food insecure individuals the breakfast is a safe, welcoming place. Some have been attending for years. Many of our volunteers have also been serving with the breakfast for decades. They too have found a family to return to each week.

The Community Breakfast program provides a rare opportunity to host many homeless and low-income in one room, so we partner with local social service organizations to connect those in need with the tools and services that address their long-term needs. Last year we formed a successful partnership with University of Washington-Tacoma's Physician's Assistant program to provide a monthly foot care clinic that addresses the serious foot needs of the homeless that are often wearing ill-fitting shoes and walking for hours on end. Community Healthcare has begun coming in on a regular basis to take blood pressure, check medications, and encourage individuals to take advantage of the free healthcare they offer. We've also partnered with organizations that have helped people sign up for healthcare and food stamps.

Though a crucial program of our church, the Community Breakfast has never been a line item in our general church budget. The generous donations of church and community members as well as grants and bequests have kept this program running for over 20 years. Our coordinators are very frugal and food is frequently donated as well. There has not been a Sunday missed in 20 years due to lack of funding, but it has been tough at times.

The Community Breakfast Program uses most of its limited funds on food and, as a result, we've had to make do with ageing equipment and space. Our church was built in 1925 and though we are very grateful for its "good bones," there are many areas of the church that desperately need updates. We are grateful for the generosity of donors and grants such as the ABCUSA Matthew 25 grant that has helped us make some of these improvements over the past few years, particularly in our large kitchen and fellowship hall which the Community Breakfast program uses. We are slowly but surely getting our kitchen up to code but still have a few projects to complete to meet the need.

This year we would like to purchase the necessary equipment to provide fire suppression in our vent hood in the kitchen. We have had the hood for several years, but because of cost restraints it has only been used as a fan and has never had the actual equipment that would activate fire suppression in case of emergency. Each week, our breakfast menu consists of hot and hearty food such as pancakes, eggs, sausage, French toast, etc. Large griddles are used to prepare these foods and there is always oil and grease. We want to make sure our volunteers and kitchen space are as safe as possible, so the installation of the fire suppression equipment will be a large step forward in this arena.

Funds received from the ABCUSA Matthew 25 grant would be used to offset the costs of food and direct service supplies so that we can use other income to complete the above mentioned equipment upgrades. This equipment would greatly increase our effectiveness and safety each Sunday and help us to sustain a ministry of hospitality, welcome, and resources in the coming months and years.
