While assistance will be available to all we believe that the elderly, people without proper cooking facilities (homeless in motels without stoves, people who cannot afford to replace a stove, renters of single rooms, etc), and families with multiple jobs and not enough time to cook will benefit the most.

#### **Description:**

First Baptist Church of Cooperstown is requesting \$5,000 in order to fund a food rescue and distribution ministry. The Village of Cooperstown in upstate New York is currently served by a food pantry that distributes canned and boxed food and vegetables. However, there is currently no organization that provides prepared food to our low-income neighbors. There is no mechanism for local restaurants, caterers, and grocery stores to donate left-over prepared food at the end of the business day, so a great deal is thrown away while our neighbors go hungry.

We hope to reduce food waste in our community and feed our hungry neighbors by collecting food from local restaurants, repackaging it into individual servings, freezing it, and handing it out free of charge to anyone in need. While our ministry will be open to everyone, we believe that several groups will be significantly impacted. Many senior citizens have a hard time cooking because standing for long periods is difficult. Homeless families living in motels or shelters have no way to cook food provided by the food pantry, and many families and individuals have more than one job and little time to cook. Cooperstown is a tourist-based economy and many people work long hours during the summer and are unemployed or underemployed during the off-season. This group (along with busy single parents and people with multiple low-wage jobs) will benefit from prepared food.

We have space to facilitate this ministry but do not have the funds we need to get started. Our kitchen space is ideal but needs a commercial dishwasher in order to be certified as a commercial kitchen in New York State. We plan to use the freezers and refrigerator to store food once it is purchased. We are requesting \$2,045 to meet miscellaneous and incidental needs of this ministry. This will primarily be used for environmentally friendly packaging for individual servings of food. We are committed to a sustainable model and will only use containers made from green products that are compostable and/or made from recycled materials. The use of green packaging combined with less food ending up in landfills will make a significant environmental impact over time. Other uses of this line-item will include advertising the ministry and helping fund deliveries of food to seniors and people without cars when possible.

Thanks, Tina,

I hope you will consider funding the appliances. They will only be used for this ministry, and the church already has other freezers and fridges to meet our usual fellowship needs.

We will spend the \$2,045 in the following ways:

\$300 advertising and mailing expenses to help get the word out. This is relatively low because we can partner with the school, office for the aging, etc to advertise.

\$1,500 will purchase packaging for the individual servings of food.

\$245 will cover expenses for delivering food to anyone who cannot make it to the church.

Once in place this ministry will require minimal funding. All of the food given away will be donated and will not cost the church anything. After we are established the main expense will be packaging for the food.
