The living condition of some members of our churches imposes us the Necessity to apply for this grant

After the 2010 earthquake that shook the island of Haiti, many Haitian families left the country and immigrated to America. They flocked to many of our churches in numerous American cities, like Boston. As church leaders, to see our fellow human beings, countrymen and fellow Christians unable to afford basic needs to get by daily is heart wrenching. Our brothers and sisters cannot work and provide for their families because of certain training problems they face and linguistic barriers in particular. In some cases, they cannot go to the hospital for fear of being deported. They cannot get a work permit to help them attain a job because they have nobody to sponsor them. In other cases, they don't find money to file for the Temporary Protected Status (TPS). They cannot find a school willing to subsidize their ESL trainings because of budget constraints or, in other cases, because of a long waiting list. They are unable to put food on the table for their children because they are not working and are not qualified for state and federal food assistance programs. If we don't act or address any of these real issues, our Haitians churches will suffer greatly and our faith will be weakened by it. Thus, our obligation as stewards of God and servants of the less fortunate of our churches is to renew our effort in providing for them these services.

The challenges for Haitians in the wake of the bad American economy

The American job market is very challenging for Haitian immigrants and second generation Haitian-Americans to thrive in. This ripple effects into making daily life very difficult for them. The women and children in particular are more vulnerable and are impacted the most. They are the two groups that tend to likely live in poverty. Most of the women have had their spouses killed in the earthquake and they sometimes find no help in raising their children. On the other hand, others sometimes are single moms from no fault of their own. Pastors and church leaders must act. This fund will help us help those people living in abject poverty.

How the grant will help us?

If we get the fund, the church members will be able to learn English and receive job and literacy trainings that will put them on equal footing with all other workers in today's American job market. By receiving ESL tutoring, computers skills, and job training, they will be able to find jobs and enhance their abject poverty status by being able to compete in the competitive American economy. The fund will also help the Pastors assist and represent those members seeking good immigration representation and assistances. The grant will help us in assisting the members in their effort to acquiring their Temporary Protected Status (TPS). We will try to subsidize a small percentage of the filing fees. We will provide legal assistances by translating and notarizing their legal documents and also provide court hearings representation, guidance and assistances. The fund will also help us help them find health centers that provide health screening services and filling out applications for subsidized housing. Their children will also receive literacy tutoring, like after school programs, which include, but are not limited to, reading and math tutoring. To remain physically healthy, to find a job, to get subsidized housing and to receive English tutoring will definitively enhance their quality of live and eradicate poverty. As in Jesus's time, when he met Peter, he did not hand Peter a fish, but He showed him how to fish. If we receive this fund, our goal is to provide them with these trainings and services in order to educate them, help them find jobs, stay healthy, and continue in serving God. That's why the Haitians American Baptist Churches are requesting this grant.

We plan to use the requested fund as the following

1. Assistance with nursing assistant and home health aide training
 - 5 vouchers of \$200 will be awarded to 3 church members in a calendar year
Cost: $200 \times 5 = \$1,000.00$
2. ESL, computer skills, job interviews skills, credit management skills, After school program (reading and math skills) tutoring
 - 3 hours per week @ \$15 an hour = $3\text{hrs} \times \$15 = \$45 \times 52 \text{ weeks} = \$2,340.00$
3. Translation and notarization of legal documents, tax filings for very low income church members, etc...
 - We will issue 10 vouchers of \$50 to 10 qualified church members for their legal service needs.
 $10 \text{ Vouchers} \times \$50 = \$500.00$
4. Accompany members to court hearings and appearances; identify and accompany them to advanced English and educational training centers; locate and accompany them to state or federal, private and non-profit food assistance and food pantry programs
 - 15 trips a year for \$20 each trip to buy automobile gasoline
 $15 \text{ trips} \times \$20 = \$300.00 \text{ a year}$
5. Purchase of a computer and printer and miscellaneous: 1 computer, work and text books, pens, pencils, board and snacks
 - 1 computer \$600+ 1 printer \$300= \$900.00
 - Miscellaneous costs \$500.00
