# How do you plan to use the requested funds?

The funds received from the Matthew 25 Grant will be used to underwrite the cost of the free monthly (all-you-can-eat) lunch that we offer. These funds will be used to purchase the food – main course, side dishes, dessert(s) and drink – for each month's lunch. A small portion may be used to purchase any paper products (small Styrofoam bowls/plates/cups, etc.). The free lunch is an opportunity for our ministry to outreach to the community and has the potential to feed people naturally and spiritually.

## How will the funds specifically assist individuals battling poverty and its effects?

The free lunch occurs on the last Saturday of every month (with the exception of holiday weekends – then it is moved back a week). We scheduled it at the end of the month because that is the time when people are in need but lack the resources to meet the need. By the end of the month, most people's food stamp allotment is depleted and pension/social security checks have not yet been issued. Our desire is to "stand in the gap" during this time for those in need.

The free lunch is also a means through which we can convey (in actions not in words) that we care about the people of our community. And while the free lunch may not eradicate poverty, our prayer is that it will fill a need at a critical time of the month.
