Grant funds may not be used to fund staff positions, rainy day funds, church benevolent funds, regular ongoing church operating expenses (i.e. utilities, insurance), repairs, or for capital improvements or repairs to facilities. Grant awards will be sent to the ABC church that is applying for the grant; checks will not be made payable to an individual or ministry.

Proceeds from the grant will be used to provide weekend grocery bags for 70-80 families currently living at or below poverty level for an entire school year. Proceeds from the grant will also serve as seed money to fund our introductory year of this program. Our goal is to set measurable goals and track progress as we intend to reach out to local businesses for future partnership(s) with this ministry. Please see the attached proposal for detailed information.

4. How will the funds assist individuals battling poverty and its effects? What impact do you hope to make on the target group or community? Northaven Elementary School is part of the Greater Clark School District. The building is located directly across the street from our church building in Jeffersonville, Indiana. We have recently begun conversations with the local school administration who is excited about the opportunity to partner with a faith based organization in an attempt to better serve the Northaven community. With over 28 nationalities represented in the building, Northaven is a melting pot of diversity. Over 400 of the 560 students enrolled are living at or below the federal poverty level. Our goal is to build relationships with these families - using the grocery

bags as a catalyst to open doors to offer life skills classes such as resume writing, training on filling out applications, how to interview, and any other areas of assistance we may be able to practically offer. We choose to start with the grocery bags because over 62% of the schools enrollment qualifies for free lunch - not reduced fee - but free lunch. The students we will serve will most likely not receive proper nutrition over the weekend due to a lack of familial resources.

- 5. Total cost of the project: \$7,500.00 is needed to serve 70-80 families each weekend for the entire 38 week school year.
- 6. Amount being requested from the ABCUSA Matthew 25 Grant: \$5,000.00
- 7. List other funding source(s): There is no other funding stream for year #1. Our goal is to show marked progress as we reach out to other local area businesses and build this into a community effort. I am a new pastor in a new community this is a first for this church. I am confident that if we approach this endeavor with great intentionality, relationships will be built, the gospel will be preached in both word and deed, families will be served, and lives will impacted. Our congregation will add this to our budget in subsequent years. That being said, the Mission Go ministry of our church has pledged a one time gift of \$2500.00 from their funding stream towards the project.

The Mission & Purpose of FBC Jeffersonville

The mission and purpose of FBC Jeffersonville is:


"to introduce people to Jesus in a way that makes Him REAL – RELEVANT – and RELATIONAL in their life"

First Baptist Church of Jeffersonville Indiana, herein known as FBC JEFF, desires to partner with Northaven Elementary School, which is part of the Greater Clark County School District in Southern Indiana. The school which is located directly across the street from the church offers an excellent opportunity for Christian outreach to students and their families – as well as – the staff, faculty, and administration.

Northaven Elementary is a diverse community with over 28 nationalities represented between grades Kindergarten through 5th. As a Title 1 building, the school has over 400 of their 560 students (2017/2018 enrollment) living at our below State and Federal poverty levels. Moreover, according to the Indiana Department of Education and the Greater Clark County School System Nutrition Services Office, over 65% of the student population at Northaven is currently receiving free lunch; with another 20% receiving reduced lunch prices.

National Education Surveys reflect the findings that students perform better academically when they receive proper nutrition not only while at school – but during the weekend while at home. While we understand that there are national programs such as *Blessings in a Backpack*, we adhere to the command of the Great Commission and thus believe that it is the responsibility of the local church to assist these families in receiving proper nutrition services. In addition, we feel as though our weekend grocery bag efforts, doors will be opened for further opportunities to assist with the following:

- 1. Life skill classes for parents (i.e. G.E.D. preparation, resume writing, employment applications)
- 2. Study tables for those students needing assistance with reading, mathematics, and science
- 3. Mentor programs for students who may come from single parent homes
- 4. Assisting the staff, faculty, and administration with current year long endeavors



Lastly, we desire to institute a ministry program that will be relational in nature so that further spiritual needs may be served by the spreading of the gospel in both word and deed. Our goal in subsequent years, is to involve the entire business community of Jeffersonville as we watch lives transformed by the power and provision of Jesus Christ.
