Community Outreach Ministry, Eastside Mission Statement: To provide food, rent and utility aid, advocacy services, financial counseling, and other miscellaneous assistance primarily to individuals with legitimate need in Warren Township and western Hancock County.

### 3. Specifically, how do you plan to use the requested funds?

COME is a multi-denomination consortium of nine churches on the east side of Indianapolis. It operates a food pantry, located at the Cumberland FBC, and when funds are available, provides financial assistance for gas or electric bills or rent. Those requesting financial assistance must live in the COME catchment area and have first applied to the appropriate local governmental agency and been refused assistance, even though in many cases their need is legitimate. Those requesting assistance first undergo an interview with a COME counselor; then the information is passed to the COME treasurer, who makes the final determination as to whether or not aid will be provided.

## 4. How will the funds assist individuals battling poverty and its effects?

The funds help people avoid disconnect of vital electricity or gas utilities, or avoid eviction for non-payment of rent. They have been rejected assistance by the local govt. agency and for many of them, COME is the agency of last resort. Typically, COME only pays a portion of their bill; they must pay the rest. A volunteer discusses their need with them and may be able to suggest additional non-monetary resources.
