Grant funds may not be used to fund staff positions, rainy day funds, church benevolent funds, regular ongoing church operating expenses (i.e. utilities, insurance), repairs, or for capital improvements to facilities. Grant awards will be sent to the ABC church that is applying for the grant; checks will not be made payable to an individual or ministry.

3. Our after school programs need normal wear and tear stuff we use all the time like pencils, computer paper, school supplies, we could use a new printer, craft supplies, balls, games, curriculum. Christmas musical, a microphone or two for our portable sound system, ping pong balls and such. We also would love to purchase Bibles for all of our kids and youth. We would

like to be able to take our kids skating or bowling. Our list could be as long as our budget would carry us. We want to provide positive life experiences for all of our children and families.

Our church is a downtown church in walking distance from the elementary school and public housing. So we are a neighborhood center. We serve some of the most needy in our city, both financailly and spiritually. We believe that we need to feed both stomachs and souls. We try to address physical needs (food and clothing) as well as spiritual needs. By pouring love onto our neighbors, we can make our corner of the world more hopeful for a brighter future by encouraging education, helping feed bodies, providing a safe haven for after school and sharing the Good News of Jesus to everyone we meet.
