The Thanksgiving and Christmas holidays typically bring to mind thoughts of worship, family, friends, memories, celebrations, food, and anticipation. But for people living in poverty, alone without family or friends, homeless, or hungry, the holidays take on an entirely different meaning, especially between Thanksgiving and Christmas. Numerous Churches and organizations provide meals on the holidays but the time in between the holidays can be a time of loneliness, sadness, and desperation. With little or no money to spend, there will not be any Christmas shopping or special meals. While many people are attending celebrations and exquisite dinners and spending time with family and friends, there are people sitting alone at home or in shelters with little hope.

Being an inner city Church provides a unique set of blessings and opportunities. God has blessed and nurtured First Baptist Church Of Omaha for over 150 years for such a time as this. A time for FBCO to host and join together with thirteen Churches for one very important mission - to show the love and kindness of Jesus by serving a meal on Saturdays to the people in the surrounding neighborhood who are without jobs, not making ends meet, or just need somebody to talk to. For some of these people, it is the only hot meal they receive each week. On a typical Saturday, over 200 honored guests are served a meal at FBCO.

We would like to use the Matthew 25 Grant to host a meal in between Thanksgiving and Christmas for our honored guests who attend our Community Meal on Saturdays. The meal would be catered in and served by the members of First Baptist Church Of Omaha to celebrate their lives and show them they are important and God loves them very much. We would like to take this opportunity to eat together, talk, and get to know our neighbors better. We want them to see FBCO as a place where they feel safe to come and learn about God, worship together, and make friends. Since many of our honored guests will not be receiving Christmas gifts, we would also like to send a small gift home with each guest.

The catered meal would be planned for 300 people. Each meal would include the following.

Salad Roll Entree Vegetable Potato Dessert

There would be a total of 280 gifts purchased. The gifts would consist of a bag with food items, a pillow, or a blanket. Please see Attachment B for the Celebrate Life Project budget.

Finances over the last ten years have changed dramatically for FBCO. The economy has taken a toll on the finances at FBCO but God has remained faithful and the congregation has remained committed. Our monthly income struggles to cover the monthly expenses. The majority of our monthly income is used for wages, utilities, insurance, and critical building maintenance. By the time these expenses are paid, there usually isn't any money left over for special projects. In 2013, over \$40,000 has been borrowed from our reserve funds. Some of the money was used for major building issues that had to be addressed such as the boiler system and water heater. God has blessed us with creative people who have a heart for the Lord and can produce a successful and exciting program on a small budget. Due to our current finances, FBCO will not be able to fund the Celebrate Life Project if a Matthew 25 Grant is not received.

We feel the Celebrate Life Project would truly be a blessing for our neighbors as well as the FBCO congregation. God is working miracles in our neighborhood every day and FBCO is blessed to be a part of God's Ministry in this community.
