ABCUSA MATTHEW 25 GRANT APPLICATION - 2018

A generous donor has given a sum of money through American Baptist Churches USA Office of the General Secretary, to be used for programs that address "housing, feeding, education and health with regard to the less fortunate." A panel will select recipients for grants of up to \$5,000. <u>Awards will be granted only to ministries</u> of an American Baptist church in good standing with their Region. This is a change from previous grant cycles. We will no longer award grants to organizations affiliated with churches such as a cooperative group that includes non-ABC churches; applications must be submitted by an ABC church for work being done directly by that church.



Only one application per church will be considered within a 24-month period.

Grant funds may not be used to fund staff positions, rainy day funds, church benevolent funds, regular ongoing church operating expenses (i.e. utilities, insurance), repairs, or for capital improvements or repairs to facilities. Grant awards will be sent to the ABC church that is applying for the grant; checks will not be made payable to an individual or ministry.

2. What ministry or group will use these funds?

The Diaconate of HMBC uses Matthew 25 funds to provide security deposits for individuals or families graduating from the homeless shelter to help them move into independent housing from the shelter. The funds are managed by the Treasurer of the Fellowship Fund, which also contains Communion Offerings, used to provide for emergency needs of people in the church and community. Matthew 25 funds are only used to pay landlords the security deposit needed for shelter graduates to move into independent housing, and only up to \$500. It is frequently necessary to supplement grant funds with Communion offerings, other grants and fundraising.

3. Specifically, how do you plan to use the requested funds? Please include a <u>very brief and specific statement</u> on how the money will be spent. For example: to purchase school supplies for 100 elementary school children; to provide summer camp scholarships for 10 children from low-income families; purchase diapers and wipes for single mothers. You are encouraged to attach a longer description (<u>no more than one page</u>) of the ministry or project.

Shelter guests may apply for a Matthew 25 security deposit grant from the church if recommended by the shelter case manager; they must complete a Rent Smart course while living at the shelter, prepare a budget for housing expenses and have proof of income to pay the rent on a monthly basis. A letter is sent with the check to the landlord, explaining that the security deposit may be returned to the tenants when they move on, as long as they have taken good care of the rental unit. Matthew 25 security deposits help shelter graduates transition from homelessness to independent living in the community more efficiently...and serve as an incentive to be responsible tenants.

- 4. How will the funds assist individuals battling poverty and its effects? What impact do you hope to make on the target group or community? Matthew 25 Security Deposit Grants from HMBC help people who need the services of the Western Maine Homeless Outreach Shelter, because of poverty. In rural areas, shelter guests are rarely itinerants, but rather local families, who just "fall off the edge" and then "couch surf" or tent camp or live in their cars until the shelter is able to accept them. Their children attend local schools and families want to keep them in school, which is nearly impossible to do, if referred to a larger shelter an hour or more from Farmington. WMHO Shelter opened in November 2013 and is normally full with a waiting list. There are only 16 beds at present, but a new location is being prepared to open in November 2018, which will be able to house 32 quests. This will mean even more security deposits will be needed. Since Farmington is a college town, rentals are very hard to come by and the average cost of rental units exceeds 30% of the median income in Franklin County. Many of the shelter graduates are disabled and can only afford subsidized units, although there is not nearly enough low-income housing in the area. WMHO Shelter receives some funding from Maine State Housing Authority, based on how guickly the shelter is able to help guests find independent housing and gain the skills to succeed at living on their own. When guests who are ready to move out are unable relocate, because they cannot accumulate enough for a security deposit, the shelter receives less funding; and beds remain unavailable at the shelter to those on the waiting list.
- 5. Total cost of the project: Since receiving our last Matthew 25 Grant from ABCUSA in October, 2016, 9 persons or families have been assisted with Matthew 25 Security Deposit grants sent to landlords. These families have remained in their new housing, successfully. Each family is visited monthly for one year by a shelter navigator who reinforces the training received at the shelter. The amount of the grant in 2016 was \$1,000. Total spent on security deposits since October 2016 is \$4,020. Security deposits requested have varied from \$224 to \$500, with most being at the \$500 amount. Some families have had to supplement even the maximum amount with additional funds of their own to be able to rent an apartment; others have had to accept housing in other communities, where there is more affordable housing.
- 6. Amount being requested from the ABCUSA Matthew 25 Grant: \$1,000. This is the amount we were awarded in 2016, after being awarded \$2,000 in 2013 and \$2,000 in 2015. With the third grant award, we realized we would need to leverage additional funds from other churches in the community in order to be able to provide more than just two \$500 security deposits. HMBC succeeded in leveraging \$2318 from other churches! HMBC shares its building with another church. Summit Faith. The WMHO Shelter is the shared mission project both churches support through special offerings. When we join together for Easter breakfast the donations are designated for the Matthew 25 Security Deposit Fund. Summit Faith is affiliated with the Christian Reformed Church of North America. In July 2018 Summit Faith applied for a grant from CRCNA to help fund Matthew 25 Security Deposits and received \$1,000. Summit Faith also contributed \$500 to cover a security deposit that was needed before HMBC could apply to ABCUSA for another grant. Additionally, two churches in the Farmington Area Ecumenical Ministry (FAEM) contributed a total of \$300 in 2017 to help, when funds were needed. FAEM has it own Housing Assistance Ministry that pays up to \$200 for a security deposit (or rent shortfall), but that program is not enough to help families graduating from the shelter. Members of HMBC have also given special support to Matthew 25 by designating \$400 in Communion Offerings for Matthew 25 in the past year.

Checks will be made payable to the church. Checks will not be made to an individual or ministry.

Nine Security Deposits were paid for persons or families graduating from WMHO Shelter, ranging from \$224 to \$500 (maximum amount). Nine formerly homeless families rehoused successfully, with follow-up from shelter staff serving as Navigators. All found housing within Franklin County.

Four other churches contributed a total of \$1,900 since 2016. Most from Summit Faith, the Christian Reformed Church which shares our building; together we share in this mission project to support the WMHO Shelter and help its graduates find stable housing afterward. Summit Faith was also awarded a \$1,000 grant for this purpose by the Christian Reformed Church of North America. Members of both churches gave donations at the Easter Breakfast in 2017 and in 2018. Both churches contributed discretionary or Communion Funds to cover the gap when a security deposit was needed but insufficient Matthew 25 funding was available. By the grace of God, each need was met. Both churches remain committed to this program, even as the WMHO Shelter expands its capacity.
