Matthew 25 Grant Proposal Rainbow Acres February 25, 2014

Mission Statement:

Rainbow Acres is a Christian Community with heart that empowers persons with developmental disabilities to live to their fullest potential with dignity and purpose.

Project for which funds are requested:

Since our foundation, Rainbow Acres has worked to make Rainbow available for families who could not afford our cost of care. Special care has been taken to assist families with a child with disabilities who have dedicated their lives to public service, such as pastors, teachers and career military personnel. Gloria Goodwin and Greg Dawson are two Ranchers who fall within those criteria. They are the children of pastors who served their congregations well, but received salaries that would make Rainbow an impossible stretch. Both Greg's father and grandfather were ordained American Baptist clergy, and Gloria's father served a number of small churches in Alaska prior to his passing. Both Gloria and Greg need significant outside support to meet their monthly cost of care here at Rainbow.

Other funding sources:

Rainbow Acres has made Gloria and Greg a part of our Adopt-a-Rancher campaign for the past several years, and is seeking to help them grow their number of monthly donors to a level that will sustain their yearly cost of care.

How Rainbow will use these funds:

If approved, this grant will be directly credited to the accounts of Greg Dawson and Gloria Goodwin to assist with paying for two months cost of care. As adults with a developmental disability, both Gloria and Greg are faced with a life of poverty. Each receives in the neighborhood of \$800 a month in Social Security. Although Greg works as a grocery courtesy clerk in a local store eight to fifteen hours a week, Gloria has been a resident at Rainbow for 36 years, and no longer has any additional income beyond the limited resources her mother can provide.

Adults with developmental disabilities are among the poorest of the poor. Few resources are available to them once they age beyond public high school. Like many of their counterparts, Gloria and Greg have very few skills with which to earn an income. They would be living a life of poverty without the generosity of donors who support Rainbow Acres, and who support them through Adopt-a-Rancher.
