### 3. Specifically, how do you plan to use the requested funds?

Since its founding, the ecumenical food pantry for the Red Bridge district of south Kansas City has been operated out of St. Peters United Church of Christ. That church is unfortunately closing and we have been asked, and agreed, to take over the food pantry as of Feb. 1, 2016. Many churches in the neighborhood contribute food products monthly to the pantry. There has also been a steady stream of financial donations from the members of St. Peter's that will be stopped once the church closes. Most of their remaining few members no longer live in this area and we don't anticipate their continuing support of the food pantry. We also have start-up costs associated with creating a food pantry on the stage of our fellowship hall and making this room separate

and secure. This will include the purchase of an institutional refrigerator to add fresh food to the canned and boxed items now provided by the pantry.

**4. How will the funds assist individuals battling poverty and its effects?** The Red Bridge food pantry already has a track record of assisting families and individuals who struggle with lack of food. Approximately 20-30 families are now assisted each month. We have hopes of doubling the capacity once we take over the food pantry in February. We also hope to expand fresh food, which currently is not included. The food pantry hasn't had aggressive outreach either to sponsoring churches or families in need in many years. We hope to re-energize the network on both sides – the churches and the families in need.

We have a large network of volunteers in our congregation who have stepped forward to give leadership to the food pantry. Three members of our church will be the coordinators: Dixie Kelly, Sue Hansen and Jim Kelly.
