

ABCUSA MATTHEW 25 GRANT APPLICATION - 2018



A generous donor has given a sum of money through American Baptist Churches USA Office of the General Secretary, to be used for programs that address "housing, feeding, education and health with regard to the less fortunate." A panel will select recipients for grants of up to \$5,000. Awards will be granted only to ministries of an American Baptist church in good standing with their Region. This is a change from previous grant cycles. We will no longer award grants to organizations affiliated with churches such as a cooperative group that includes non-ABC churches; applications must be submitted by an ABC church for work being done directly by that church.

Only one application per church will be considered within a 24-month period.

Grant funds may not be used to fund staff positions, rainy day funds, church benevolent funds, regular ongoing church operating expenses (i.e. utilities, insurance), repairs, or for capital improvements or repairs to facilities. Grant awards will be sent to the ABC church that is applying for the grant; checks will not be made payable to an individual or ministry.

Awards will be granted only to ministries of an American Baptist church in good standing with their Region. This is a change from previous grant cycles. We will no longer award grants to organizations affiliated with churches such as a cooperative group that include non-ABC churches; applications must be submitted by an ABC church in good standing.

When determining Grants awards, the following criteria will be considered: whether the church is in good standing within the region; whether the church contributes to United Mission; number of and amounts of previous Matthew 25 Grants received; sustainability of ministry beyond Matthew 25 Grant funding; description of ministry and needs addressed by funding; and the budget submitted along with this application.

Checks will be made payable to the church. Checks will not be made to an individual or ministry.

Report of Use of Funds

Despite its reputation as a “university town”, the city of Cambridge continues to have many serious social problems. The most critical needs can be found in the large neighborhood surrounding the Massachusetts Avenue Baptist Church, officially designated as Area IV. With five public housing projects, including two for the elderly, Area IV is Cambridge’s most vulnerable district.

One of the area’s most pressing problems is that of homelessness. City Officials cannot state precisely how many homeless dwell in Cambridge. All homeless persons lack the basic necessities to secure food and prepare a warm, healthy meal on a regular basis. These persons need to be fed; if the immediate need is not met, homeless individuals will have little chance to maintain his or her health and make a change in life for the better.

The plight of the hungry, however, is not confined to the homeless population. With the ongoing economic downturn and the reduction of services from the federal, state, and local governments, we continue to see an increase in our service to the working poor – poor who do not earn enough to provide for the basic human needs; shelter, food and medical care. Project Manna allows us to provide a neighborly helping hand to their need for nutritious food. The Food Pantry serves mostly families with children even though there are an increasingly number of single persons who are asking for help. The Soup Kitchen serves meals twice a week to anyone who walks in.

We continue to serve an average of 250 homeless individuals in the Soup Kitchen and provided groceries for over 300 families as part of the EPIC Food Pantry program.

FEMA mandates that we serve all of Middlesex County; however, most of our clients come from the surrounding neighborhoods and Boston. The community recipients we serve include Portuguese and Brazilian, African-Americans, Haitians, persons from other Caribbean Islands and European, eastern European and African countries.

We continue to see low-income families coming to the Soup Kitchen to supplement their food dollars. Our Holiday meals programs, which were added in 1996, continue to provide not only food, but also a sense of family/community for people who would otherwise be lonely during a season that expresses and supports fellowship.

There is no indication that the need for our services will be decreasing, in fact, we have seen a notable increase in the number that we serve. There has been a decrease in the amount we received from gift givers, thus, that impacts our purchasing power and our food purchase schedule. Last year, we were not able to offer the EPIC Food program every month due to low or no funds to purchase the groceries to supply to the families. And when we open our doors for food distribution, the lines are always long. We have clients who camp out over night to make sure they are “first” to get food.

For over twenty years of our program’s services to the community, we have been able to offer food, conversation and hope to those who come through our church doors. It is important to a community to know that the church is available in time of need. We do not generate profit from our services, so we will continue to need fundraising partnerships to support the ministry.
