Grant funds may not be used to fund staff positions, rainy day funds, church benevolent funds, regular ongoing church operating expenses (i.e. utilities, insurance), repairs, or for capital improvements or repairs to facilities. Grant awards will be sent to the ABC church that is applying for the grant; checks will not be made payable to an individual or ministry.

# New Beginnings Christian Community Mission Statement

# Our mission is to be "God's Community of Hope and Healing to all in Jesus Christ and the Holy Spirit."

This mission is further expressed in our church Covenant:

In the presence of God and this community, having confessed Jesus Christ as Our Lord and Savior and relying upon our Creator God and the Holy Spirit for wisdom, power and love, we joyfully covenant with each other.

We will pray for one another and the world, worship together, and regularly celebrate the Lord's Supper together.

We will seek God's guidance through prayer, reading the Bible, and listening to the community of faith.

We will welcome all people in the name of Christ, empowering them in the gifts that God has given them.

In gratitude for all that God has given us, we will support the worship and ministries of the church.

We will continually strive to love all people as Christ has loved us, compassionately caring for those in need as reconcilers and peace-makers.

# Use of Requested Funds

Our church was founded in 2002, with a grant from the Church Planter's Institute of the American Baptist Churches. Our vision was to minister to those who were not welcome in traditional churches: the homeless, addicts, alcoholics, ex-offenders and sex offenders and their families. We began with Bible studies and soon were asked to have worship on Sundays. Since that time, sixteen years ago, we have become an established church, with a rented building, a constitution, a diaconate, trustees, a part-time secretary, two co-pastors and an associate minister.

While our church has grown in number, spirit and witness in our community, we have struggled with finances. Our members are generous with the little that they have. Many of them find it very difficult just to make it through each week. In 2004, we noticed that many of our members came to church hungry and we started providing breakfast for them. Then we tried to gather groceries from our congregation, but few had many items to spare. Under the guidance of two of our members, we applied to the Blue Ridge Food Bank for membership in their community food pantry. We were not only welcomed to buy their food at greatly reduced prices, but also referred to Walmart and Food Lion for weekly donations to our Food Ministry.

Over the last 14 years, we have seen our numbers grow as well as their need for subsidized groceries. Every Saturday, we provide 80-120 people from our church and the community with 1,000 lbs of food for their families, which includes; meats, vegetables, fruits, pastries, bread, dairy, dry and canned goods. Food Lion and Walmart are very generous, but they rarely have spare canned goods. Many times we have had to restrict our recipients to taking only 2 cans a week, hardly enough to provide what they need for a hungry family. We can purchase canned goods from the Blue Ridge Food Bank for only 5 cents a pound. Three hundred extra cans a week, would certainly help our 80-120 hungry people provide balanced meals for their families.

Recently, we noticed that the local soup kitchens were closed for dinner on Thanksgiving, Christmas, Holy Thursday, Easter and other holidays. Many people spent these days of celebration alone and hungry. We want to offer turkey, chicken and ham dinners to the community, both on the Sunday before the holiday and on the day itself. Pot-luck meals do not work in our church, few of our diners have the resources or the kitchens to prepare food. Thus, we need to buy chicken, ham, turkeys, beans, lamb (for Passover) and fixings.

One of our members requested this year that we have a Friday night meeting with a movie and time to talk. He wanted us to open our church to the recovery community on Friday nights, which is the time of the greatest temptation for addicts and alcoholics. Thus, we began The Open Door Intervention Ministry. Many homeless and hungry street people come to our Friday night meetings. They have not eaten since their lunch at the noon soup kitchens. The folks who attend do not have the money to contribute to these meals.

As our reputation for helping those in need grows, so do the opportunities to witness to Jesus' love for everyone. We have been asked by our local homeless shelter network to care for 20 homeless women for the week after Christmas. The PACEM program rotates among churches and synagogues in our community. Each congregation hosts the women or men for a week or two in their building. They are expected to provide their guests with dinner and breakfast. Since our members have such limited incomes, we will need to purchase the food.

We want to "feed the hungry," as Jesus commanded us to do, but we need your assistance to fulfill this sacred mandate. Help us open our church to the hungry so we can feed their bodies and souls.
