Our Mission Statement

As a Christ centered association, the Community of Hope will support North Portland homeless families. We will build on the strengths families already have while providing housing, classes, resources, and mentoring. This support will help parents to hold a job, manage finances, steer clear of addictions, develop positive relationships, grow in parenting skills, and make healthy life choices, all in the context of Christian community.

Our Plan for the Use of These Funds

The Community of Hope is a program that serves North Portland homeless single mothers and their families. We are asking for \$4932, to pay for the installation of showers and laundry facilities, the permits to change the zoning to meet city requirements, and for classes and emergencies.

There is a great need for this service. Portland Public Schools has identified over 150 families in North Portland that are homeless. There are no transitional housing programs in our neighborhood that serve most families with children. Several churches in North Portland, including Rivergate Community Church, decided to do something to meet this need by opening the Community of Hope this fall. Carren Woods, Rivergate's pastor, is on the board.

The Community of Hope will provide both shelter and support for change that can lead to stable living situations for four or five homeless single mothers and their children. As they battle poverty and its effects, we will offer classes, mentoring, and support groups to help train families in skills that will support their journey toward long-term stability and better relationships. As a result of this program, there will be fewer families continuing the generational poverty that is growing in our society and more families able to make a contribution to our neighborhood.

We will use space donated by area churches. Red Sea Church is providing overnight space every night and rooms for classes, childcare, and meals several days each week after school. St. Johns Christian Church will provide space other days, and other churches will fill in when they are both full. We have one staff person and many volunteers who provide overnight care, child care, meals, extra classes, and many other services. We are partnering with several agencies to provide classes and take referrals.

We believe that offering this program as a faith based initiative will support the families we serve to make real and permanent changes in their lives. Change is hard. For many families, adding the spiritual component will make a vital difference. The tools we share will help them make changes even without the spiritual component if they choose not to use it. The

motivation of loving service by the volunteers and staff will give support and encouragement to
all the families we serve.

American Baptist Churches USA Mission Resource Development Matthew 25 Grant

Dear Matthew 25 Grant Fund.

I am the Senior Pastor at Rivergate Community Church. We are an American Baptist Church that has been serving the North Portland community for 60+ years. I have been at Rivergate for 12 years next month and have been praying for the opportunity to make a difference in the local community. North Portland has been a tremendously under-served part of town for decades. There is generational poverty in this community, and we as the church, have not done a good job of responding to the needs.

A little over two years ago I started meeting with a group of pastors from other small churches in North Portland. We did a survey to identify unmet needs in our community and found that there were no programs that addressed the housing need in North Portland. We began to pray together as a group and to seek what the Lord would have us do. During that time it became clear that a transitional housing program which was focused on Christian principles that could change this pattern of poverty was what the Lord was asking us to provide. We have continued to meet with other churches, non-profits and city leaders to come up with a plan that addresses this critical need.

Community of Hope is the outcome of those meetings and prayer. We knew that we needed to have a separate group that would oversee this program, and I serve on the board of directors for this ministry. In addition, we have many of our Rivergate church members who are volunteering for the program. We are also helping to coordinate the fundraising efforts for Community of Hope. We are excited that Red Sea Church has opened its doors to allow us to make some renovations that will allow us to house 4-5 mothers with children in their facility. The grant funds would be used to help cover those costs of installing showers and laundry facilities for the families.

The Lord has led us on this journey for the past 2+ years, and the reality is now in sight. We just need some funds to cover these expenses and then we will be able to open the doors to families this fall. We know from other similar programs that this will change the lives of these families and open the door for them to find and secure permanent housing and employment. There are no large churches in our part of town, so it has taken a group of small churches coming together to get this project off the ground. I am honored that Rivergate Community Church has been part of this ministry, and I am excited to see what the Lord will continue to do in North Portland.

I believe that the Matthew 25 funds requested for this project will change lives in North Portland. I hope that the committee will be able to support this project with a grant this year. Thank you in advance for your time and consideration. If you have any questions, feel free to contact me,
