Thank you for your request for additional information on question # 3 of the Matthew 25 Grant Application of how the proposed funding will be used.

Q: How do we plan to use the requested funds?

A: All requested funds from ABCUSA would be used in totality to purchase food. Our goal since our inception is to expend all financial contributions on food sufficient to meet the needs of individuals up to a maximum of seven to ten days once per quarter.

Q: How will funds specifically assist individuals battling poverty and its effect?

A: As stated within our proposal we are housed within the Kalamazoo Deacons
Conference located one block from our facility. Many of the clients who use their are underemployed, unemployed, homeless, and often without basic if any food. The Kalamazoo Deacons Conference houses resources such as counseling, clothing, and in some situations allows individuals to complete community service work.
Often times individuals who come seeking food are encouraged to volunteer their services and in some instances their volunteerism has led to them gaining employment. Our food services are available to families once per quarter; however, we do also act as a referral in some cases to those who may need resources beyond our scope.
All volunteers are trained in food safety and compliance with respect to equal treatment of all persons in need. All individuals are encouraged to seek means of improving their situations. We have experienced that "people in need don't care how much you know, until they know how much you care".
