**Families** By Choice

The sunshine within our trademarked symbol reflects the Light of the world, Jesus. The house is reflective of the shelter we find within Him. The green grass reminds us that He loves us as we are, but we honor Him by growing.

Our Mission Statement: "Families by Choice meets the basic needs of persons at a distance from their family of origin either geographically or emotionally."

We serve the homeless and hungry in Terre Haute, Indiana. Most of our homeless clients come to us with a few clothers and little else. We supplement their food stamp allotment once a month. Our first program opened in 2007, Deborah's House, a transitional home for single mothers, and their young (12 and under) children. In 2009, FBC opened *Timothy's House*, transitional housing for men with preference given to those exiting foster care. In 2012, FBC opened Project *Jonathan*, for adults with mental handicaps who have been abused, or abandoned by their family.

Please note that when you see "FBC" it stands for Families by Choice, NOT First Baptist Church as our pastor, Fred Harrison, always teases us. We represent God's love to those without family and resources. We draw them in to the FAMILY of God and develop skills for independence.

#### **NEEDS**

\$1800 EDUCATION: Tutoring for our Women and children's homeless shelter

- for children who have missed skills due to transferring schools so often
- for mothers working on their GED

Tutoring for our men's homeless shelter

- Special case: 19 year old confined by his parents from education and medical care for 18 years; Parents told he and his brother they were doing it in the name of God. He didn't know God could LOVE him. He and his brother fight not only poverty, but abuse.
- \$1500 HEALTH: Funds for co-payments for sliding fee health care and discounted medications May of our homeless come with nothing except a few dirty clothes. We start with healing the mind and body as well as the soul. Physicals, evaluations, and lots of love. Reconstuting minds, bodies and souls moves people to self-sufficiency
- \$1200 SOCIAL SKILLS: Tuition to allow a special client to attend a special school. The 19 year old mentioned above has a 21 year old brother who was isolated as well and is mentally handicapped. He needs special assistance which is available for mentally handicapped adult school near by. The school has a slidding fee---3.85 an hour. He needs to be there about every weekday for 5 hours. State assistance will not kick in for at least three years. SSI gives this young man less than \$700 a month to live on. Without these skills he will not quailify for even the most minial job.
- \$500 TRANSPORTATION: If our clients had a car, it has been sold or repossessed. They have no transportion. We have volunteers who help them to appointments. But these persons need independence. Bus passes allow them to job hunt further than walking distance.
