This category covers benefits or services that are designed to deal with a specific crisis situation or episode of need, are not intended to meet recurrent or ongoing needs, and will not extend beyond twelve months.

• Host one-time domestic violence workshop during the month of October that will educate the community as a whole and to introduce service providers that is available in the area.

## Problem

Domestic violence is one our country's greatest public health problems. The crime is chronically under reported, is most often perpetrated by an intimate partner or a known person, and can have devastating and lasting physical and emotional effects for survivors and their children. In response, Health Imperatives offers a comprehensive and coordinated spectrum of care for survivors of domestic violence, which includes emergency shelter, crisis counseling, legal and court advocacy, and education and prevention activities.

## **Penelope's Place**

Penelope's Place, and the comprehensive services we offer, is often the first stop for the region's most vulnerable families and children and we are often the last chance for survivors of trauma who have nowhere else to turn. A five+ bedroom shelter, here we provide survivors of violence with safety,

security, and comfort. With the support of local community groups, schools, and churches, we have worked to ensure the health and safety of the region's most vulnerable families and individuals. Without the support of the local community, we would not have been able to transform our shelter, including providing residents with comprehensive care and making major structural, electrical, and plumbing improvements to the home. We are now seeing families with more complex needs and with increased costs and declining revenues, we have been challenged to adequately meet these demands. As such, your support is more vital than ever.

In FY15 we provided shelter and supports to 55 survivors of domestic violence and their children. The majority were women with low- to moderate-incomes and low educational attainment and/or employment experience. Regardless of their backgrounds, the common thread linking all of the families and individuals that we served are that they are all survivors of trauma. Experiencing domestic violence is an overwhelming, traumatic, and often devastating experience. In addition to the physical effects, survivors often experience significant emotional and psychological trauma.

The Centers for Disease Control and Prevention estimates that 1 in 3 women and 1 in 10 men have experienced interpersonal violence including physical injury and rape. Research indicates that as a result of these crimes survivors often feel isolated and ashamed and can suffer physical injury, depression, anxiety, and other physical and emotional illnesses. There is also a high prevalence rate of substance abuse among survivors, adolescents are more likely to drop out of school, and children who witness violence are twice as likely to abuse their own partners as adults.

In response, the services and supports that we provide at Penelope's Place are survivor-centered, trauma-informed, and are successful in reducing the physical, emotional, and economic toll that domestic violence can have. We provide comprehensive care- including shelter, crisis counseling, advocacy, and safety planning- and support survivors through all aspects of their recovery and healing. *Penelope's Place is the only provider of these critical services in Plymouth County*. We operate the only sexual assault counseling center and one of the only domestic violence shelters; as such, our programs fill a critical void for vital care in the region.
