  - We are an American Baptist congregation living our lives rooted in Jesus Christ. As such, we embrace all people while proclaiming joyfully the life-changing message of God's love and eagerly accepting the commission of Jesus Christ to help bring compassion and healing to all creation. The Center for Spiritual Health at Morgan Park Baptist Church is the outreach we provide to the people of Beverly/Morgan Park to bring opportunities for healing.
  - A financial statement FOR THIS MINISTRY. The proposed budget for helping the less fortunate in our neighborhoods by providing professional counseling to those who cannot afford counseling is \$3,250. It is broken down as follows: 60 (sixty) hour-long sessions of professional counseling by a Licensed Clinical Professional Counselor (LCPC), licensed by the State of Illinois, provided to low-income adults, children and families at a cost of \$50 per session and \$250 to help promote the program in our community.
- 3. How do you plan to use the requested funds? How will the funds specifically assist individuals battling poverty and its effects? Our neighborhood in Chicago shut down its city-run Mental Health Clinic due to budget cuts in 2013. There is a serious gap in providing professional counseling to low-income individuals and families in our neighborhood. The State of Illinois has received a grade of D when it comes to providing mental health services. This is especially so for people with low income. This crisis has grown because of our State of Illinois budget impasse. The Center for Spiritual Health at Morgan Park Baptist Church wishes to expand its services to cover some of the gaps in mental health services for those with low-income. We were awarded a grant of \$2,500 in 2013 to initiate this program which has been very successful and has been written about in local newspapers. We received an additional grant of \$2,500 in April, 2015 and have used those funds as mandated in our grant application. Written reports of counseling services for the years 2014 and 2015 are available by request from the church
