## 2. Mission Statement:

Our project began in 2011 by filling the needs of the homeless teenagers in the Oakland community by providing a backpack filled with nutritious food and personal hygiene items on a weekly basis. Our project also provides individual tote bags filled with healthy snacks for the winter and spring vacation week to elementary school students who have been identified by school personnel as economically disadvantaged and unable to provide their own snacks.

The Mission of *Blessings in a BackPack SnackPack* is fivefold: 1) Provide nutritious meals and personal hygiene items to teens in the RSU 18 school district who are homeless (identified as not living with their immediate family) via a weekly backpack. Also, we received a request in October from the Messalonskee High School Guidance Office to provide daily nutritious snacks to 15-20 teens daily 2) Provide daily snacks of fresh fruits and granola/protein bars for students at Williams Elementary School 3) Provide individual SnackPacks filled with healthy snacks to elementary students at the Atwood and Williams elementary schools during the winter and spring vacation weeks with a cost increase of 11% for February 4) Provide a \$200.00 annual grant to each of the Belgrade, Sidney and China elementary schools for healthy snacks for economically disadvantaged children and 5) Provide a large duffel bag filled with weekend meals for needy families identified through the school's guidance staff.

## 3. Requested Funds and How Grant will be used:

We plan to use the Matthew 25 grant for that portion of the project that provides fresh fruits, vegetables and hearty snack bars to the students of Williams Elementary School. The school lost their USDA grant because they dropped from 57% required for free or reduced lunch to below 54%. This grant is very important to our team because we have started supplying additional daily snacks to help fill the need of 15-20 students at Messalonskee High School at the request of their Guidance Office.

Our grant request will fill the void for Williams Elementary School because their grant was lost from the USDA funded Fresh Fruit and Vegetable Program. This request is in addition to the February and April vacation snacks we already provide to 150 Williams Elementary students on free and reduced lunch. We anticipate that the snacks will be distributed throughout the 300 plus Williams' student body. The elementary student's nutrition, learning and self-esteem is promoted through the healthy snacks.
