2. Mission Statement: Since opening our doors October 1, 2013; Family Promise of the Palouse (FPP) successfully pursued its mission of providing shelter, food, counseling, and comprehensive case management for newly homeless families in the sister cities of Moscow, ID and Pullman, WA and the surrounding rural areas of Latah County, ID, and Whitman County WA, known as The Palouse. FPP is affiliated with the national Family Promise organization based in Summit, NJ whose mission is "to help homeless and low-income families achieve sustainable independence"; for more information, see www.FamilyPromise.org. At the local level, families (guests) are housed in host churches which provide shelter, food, and supplies. During the day, adults are found at our Day Center, where our director and case manager assess factors that led to homelessness, develop a family plan, assist parents in finding employment and housing, and see the children continue their schooling; for information on our local organization, see www.familypromisepalouse.org. The United Church of Moscow (ABCUSA), 123 West 1st Street in Moscow, is a partner church assisting one of the 11 host churches with lodging and meals. In addition, members of the United Church of Moscow serve as volunteers, participate on the FPP Board, contribute to special event fund raising, and assist with grant writing.

Budget: The Family Promise of the Palouse budget is very cost effective through the use of churches for lodging and meals, and many volunteer services. Our paid staff includes our full-time executive director, part-time case manager, and two part-time van drivers who also act as program assistants in areas where they have additional skills. Our Day Center rent and utilities are provided at a reduced rate through the generosity of a local hospital. A copy of our actual annual operating budget for the most recent completed year of 2014 is included as an attachment.

3. Use of requested funds: We are requesting \$2500 to support the operating costs of our parent training classes. Family Promise of the Palouse emphasizes increasing the ability of families to meet the daily challenges that often disrupt their ability to maintain employment and housing. Early in our experience, we identified that many families were having difficulty managing their children's behavior, resulting in disruption of their employment, conflict with other families and ability to maintain stable housing. When families were having difficulty managing their children, they were making little progress on the goals of their case plan. We addressed this issue with a contract to provide parenting classes. These classes are offered to families in our program and those who have completed the program (called aftercare). This was very well received by the families and resulted in many positive observations of changes by the staff and volunteers. The contract cost of \$2500 for a year has proven to be a valuable service. The request of \$2500 allows us to purchase the 8 week course 5 times per year. An added bonus is that participants may start at any time and also may repeat classes in the future. This support service is significant to our mission of preparing families to develop the life skills necessary to secure and maintain a stable income and housing.
