Weirton Christian Center has been a making a difference in the community since 1917. Our preschool serves children three, four and five years of age. The Afterschool Program It exists as a ministry of the Weirton Christian Center in Weirton, West Virginia...available 5 days a wee, k

Mission: Serving God and Community with an emphasis on Children, meeting their spiritual, physical and mental needs.

The Weirton Christian Center has been serving the Community for 98 years and as the community has changed, so have the needs of our families, and the programs of the Center. For years, Weirton Christian Center offered the ONLY Kindergarten in the city – with outpost locations until 1979 when it was taken into the School system. We soon after started a 4-year old pre-school. Since 2006, our focus has been is hands-on Christian Curriculum that meets state standards. We opened up to 3-year olds, in anticipation of the addition of Pre-K to the public schools two years ago.

One of our initial problems was the parents were not getting their children to us, so we now offer free transportation, to our free program for 3 to 5 year olds daily from 9 AM to 1 PM. Last year, we added ABC Mouse on computers to broaden their learning experience. We provide them with healthy snacks, Christian music, teach them to pray and by the end of the year they know The Lord's Prayer and all pledges to the American Flag, Christian Flag and the Bible. They also learn many scriptures and Bible stories that are reinforced with activities and songs. At this age, they are like sponges and as we pour God's Word and ways into them we are even affecting others in their homes. Many come from homes where parents are in jail, or rehab and our area is tying for number one in heroin overdoses for the state of West Virginia - which has had 2000 overdoses in the last 6 months. Most of our children are on free lunch at school and our neighborhood is lowincome.

We plan to remain the "FREE" **CHRISTIAN Choice**, for a developmental Pre---School, but we need funding to provide these services for free. The funds we are requesting will help us be able to continue our reputation for how well our children are prepared for Kindergarten. We have heard from several teachers and of course, numerous parents.

If we may, we would like to also include our Kindergarten and First Grade Classes in the Afterschool program as part of this request. We would like to ask for the funding to also cover some expenses for them. These children travel to the geriatric centers each "Mission Monday" and are a tremendous blessing for everyone they see. This teaches them so much about God's love. They pray with residents and sing wonderful Christian songs with them. Most are coming right out of our preschool and their hearts are totally about Jesus.

Our request for funding would not only include teaching, transporting and healthy snacks for the Preschool but also help with the afterschool program for the youngest ones in Afterschool who we transport to the Geriatric Center and the Library weekly.
