How I Will Use These Funds to Assist Individuals Battling Poverty and Its Effects

Any funds expended to me by this grant will be used to continue the work of providing very short term provisions to those who are marginalized in Oakland, CA. With the funding I will be able to restock and increase the number of provision packs that can be passed out to those who are begging, especially those who have small children. We are currently completely out of provision packs. Additionally, I can Increase the LOVE & COFFEE events from once per month to weekly and include sandwiches.

Transforming Ministries Group provides very short term provisions to individuals who are homeless and/or without means to adequately care for their own personal needs, for whatever reason, and who ask for money and/or handouts in public places, such as in front of the U.S. Postal Offices, at fueling stations, near freeway on or off ramps, etc. Not wishing to contribute to any substance abuse issues that individuals may have, the ministry puts together provision packs in large Zip Lock bags that consist of single servings of beef jerky sticks, cheese sticks, cheese-cracker snack packs, cookie snack packs, bottled water and juice boxes, travel size toiletries such as a bar of soap, deodorant, sanitizing gel, a toothbrush and toothpaste, lotion, a couple of sticks of gum, a tin of Vienna Sausage, a small apple sauce cup, two Band-Aids, and a hair comb. A note is included with these provisions expressing that recipients are loved by God and that they are being prayed for daily by this ministry. We also provide waterproof disposable rain ponchos, warm hats, & fleece blankets to shield against inclimate weather. In January 2015 I expanded this to include the sub-group LOVE & COFFEE, which passes out hot cups of coffee on Sunday mornings to those who are found sitting along sidewalks, as ministry members sing songs of praise and lift up prayers for the marginalized in various locales around Oakland, CA.

This ministry to the poor actually started in 1998 when I assembled Easter baskets containing treats and travel size toiletries for clients of the Allen Temple Baptist Church AIDS Ministry. Thereafter I regularly assembled short term provisions and passed these items out to those who lingered in front of public offices and spaces seeking handouts.

In 2010 I solicited the assistance of a fellow seminary student and passed out nearly 40 Thanksgiving dinners to residents of Berkeley's People's Park. In December 2014 I formed a nonprofit to pull together my work in urban ministry as well as my ministry to provide training to congregations for setting up primary prevention education programs for teen girls at risk for human trafficking.

People on the streets know where to find shelter and provisions, but often they don't have the means to reach those places. My ministry provides a very short term, stop gap solution of relief to those who are extremely hungry and exposed to the elements in the moment, until they are able to obtain more sustainable assistance.

Thank you Tina. Actually we are both. The primary reason I formed an independent 501 (c)(3) was because my ministry was not receiving any support - - financial or otherwise - - from the church except for donations from one of the women's mission society groups and contributions from various church members.

This is something on which our Community Care Cluster is working, as several of the ministries under this group are in the same position. I have been paying everything out of pocket for my ministry, but since I retired in September I no longer have the means to continue doing that.

Our Community Cluster Ministry Group had its quarterly meeting on this past Saturday and the cluster leader stated he needs clarity from church leadership as exactly how to classify the unfunded ministries who have independent nonprofit status. All Community Cluster ministries have been functioning under the 501(c)(3) umbrella of the Allen Temple Health and Social Services ministry, but when the decadeslong ministry leader resigned in January that left a lot of things in question. Currently only two ministries in this cluster are receiving any funding from the church.

If this renders my ministry ineligible to receive Matthew 5 Program funding, that is understandable. God will continue to provide. Thank you for your reply.
