New Horizon Baptist Church is a modest sized congregation that serves the Greater Hartford community of Connecticut. Statistically, the Hartford Metropolis is one in the top areas of poverty in the United States. Many families are either low income or unemployed. This condition affects not only the adults, but the children as well; and has impacted their need for food, clothing, shelter and even their ability to obtain an education. As a mixed congregation, the New Horizon family encompasses members who have fallen victim to the bleak economic climate and who look to our organization as a means for Spiritual and limited economic support through the provisions of clothing and food items. Bearing witness to the significance of our sacrificial giving to those in need, we have always felt compelled to extend our reach to beyond our four walls. Six years ago, New Horizon introduced our annual "Back to School Community Day."

Over the past 6 years we have distributed book-bags filled with school supplies, clothes, food, person hygiene items and small household items free of charge to all attendees. Our program also consists of lectures and workshops about healthcare and mental disorders. Last year, our resident law student gave a general overview on starting a legal claim and how they should present themselves when attending legal proceedings. Each year, the visibility of the program has grown, and last year we were pleasantly forced to find a bigger venue.

While we seek to maximize, as we have done in the past, the resources that New Horizon has allotted to this event in the most efficient way possible, our reach has been exponentially increased with the assistance of the Matthew 25 Grant in the past. The requested funds will be used in assisting in preparation for the event as outlined in the proposed budget.
