## I. MISSION AND VISION STATEMENTS

The mission statement of this Church, as adopted in August, 2011, attempts to speak to a number of Biblical doctrines and disciplines; it further attempts to encourage this assembly of believers so that we might find unity in our commonalities and desires to serve Christ and the community. The mission statement says: *We are a church, empowered by God, to minister and witness to this community. Charged to open blind eyes and transform God's people from darkness to His marvelous light. To preach and teach the Word of God, with prayer and love as the foundation. To share in Christian unity and be a place where all are welcome.* We stand behind this mission statement.

God also wanted to unify us in our worship experience by giving us a simple vision statement. As we analyze and strategize on how He would have us to grow the church, it became quite clear that the Bible spoke directly on this subject. In August, 2011, we also received and accepted this vision statement, as lifted up from John 12:32: *And I, if I be lifted up from the Earth, will draw all men unto me.* We believe and know that it is the power of God that can attract all of those whom He has called to his service at Zion Baptist and this community. We stand behind this vision statement.

## **II. How will the funds be used?**

The funds will be used as seed money to enhance the anticipated relationship between Zion Baptist Church and Lisa's Daycare. This exciting joint venture will create a community outreach program that will result in the establishment of a community day care facility on the church grounds. The day care will be responsible for housing thirty five children, fourteen hours per day, six days a week. This environment will allow for impoverished and indigent single mothers and children to be cared for at a state licensed facility.

How will the funds assist people in battling poverty and its ill effects?

The poor families of the local community will have an opportunity to have their immediate needs met. There will be educational activities, clothing opportunities and a state sanctioned feeding program. The mothers will benefit by being free to seek educational and occupational opportunities to help lift them from their cycle of poverty and despair. They will also be nurtured in a Christian environment which could lead to souls being won to Christ.
