BOARD OF GENERAL MINISTRIES RETREAT

Thursday, June 16, 2016 (9:00 a.m. – 6:00 p.m.) – Friday, June 17, 2016 (9:00 a.m. – 12:00 p.m.)

Brayton Case, Kern Lodge

Participants: The Board of General Ministries; ABCUSA-Office of the General Secretary Board-Related Staff; Marcia Patton, Charles Revis, John Williams (Region Executive Ministers), the General Secretary's Search Committee members of the ABC Nominating Committee and the General Secretary's Search Committee, and Doris Garcia-Rivera (presidenta de Seminario Evangelico de Puerto Rico), also a member of the General Secretary's Search Committee.

Participants gathered in a retreat setting for a day and a half to intentionally focus on building relationships and to explore issues of race, gender and culture, recognizing the impact of those issues on our life together as a denominational family. During this time, participants also contemplated how to best leverage the gift of diversity as it discerns leadership for the future of the denomination. The retreat was facilitated by consultant Erin Hawkins, General Secretary of the United Methodist Commission on Religion and Race.

ABC President Judy Fackenthal welcomed participants and led in prayer for the family of Rev. Dr. Roger Fredrikson, former ABC President (1970-1971) and long-time pastor and social justice advocate, who passed away on June 16, 2016 in Sioux Falls, SD.

Camille Brown, Chair of the Beloved Community Action Group shared an opening devotional on Thursday morning based on I Corinthians 12:12-27 (one body, many parts, each dependent upon the other) and BGM chaplain Kay Farley shared an opening devotional on Friday morning based on Genesis 45, the story of Joseph (truth can hurt, but when it is poured out, it is love that sets us free).

Retreat participants heard introductory remarks from Wesley Sun and Shirley Fair, two of the members of the Beloved Community Action Group, who worked with Erin to plan this retreat. Also, President Fackenthal addressed the “elephant in the room,” referring to lingering emotions and feelings that stem from a former failed search for ABC’s General Secretary and the undergirding question: Did race and gender play any role in what took place? She stated that it is important to recognize the truth and the pain that may have stemmed from the failed search, to name it, and to hold a place within ourselves to recognize it. She also noted that we gather to raise awareness that the “elephant in the room” is among us and encouraged participants to a keep spirit of openness as God leads us into new pathways. Time was taken to respond to any questions regarding this or how the retreat will move forward this afternoon.

In the afternoon there was an opening group exercise and a time of covenant setting. Participants met in small dialogue groups, each led by a facilitator, and shared stories of times when they experienced joy, grief, hope and commitment in ABC life. The second day BGM began to delve deeper, through times of reflection and sharing, into conversation related to race and gender issues that impact us as a board and as a denomination. Participants identified possible causes for roadblocks in order to clearly understand what has gotten in the way of living fully into being the beloved community and in order to inform future steps forward.

President Fackenthal thanked consultant Erin Hawkins for her leadership and she thanked the 4 members of the Beloved Community (Camille Brown, Felipe Candelaria, Shirley Fair, and Wesley Sun) who helped plan the retreat.

The retreat concluded with a time of worship and communion around the Lord’s Table.

BGM 281

WELCOME AND CALL TO ORDER

Judy Fackenthal thanked Dianne Steelman (ABC of Ohio) and Wesley Roberts (ABC of Massachusetts), who served as Tellers for this meeting. She also thanked Nancy O’Neill (ABC of Wisconsin) and Andy Arndt (ABC of Indiana/Kentucky) for their ministry of music during the retreat and during the BGM meeting.

She shared regrets from those not able to attend this meeting—Danny Jack (trip to Burma), Dennis Johnson (move to Kentucky), Kelly Legg (sabbatical) and Dean Parker (son’s graduation)—and recognized BGM directors attending their first meeting: Raimundo Barreto, General Director from ABC of New Jersey; Zina Jacque, General Director from ABC of Metro Chicago; and Tom Ross, General Director from ABC of Metro New York, who served on the General Board several years ago.

Judy introduced the following special guests: Doris Garcia, President, Evangelical Seminary of Puerto Rico—serving on the General Secretary Search Committee as representative of the 3 other national organizations; Marcia Patton, Executive Minister, Evergreen Association of ABC—serving on the ABC Nominating Committee and GS Search Committee; and Rev. John Williams, Executive Minister, ABC of the Central Region—serving on the ABC Nominating Committee and GS Search Committee

BGM 282

OPENING WORSHIP

Kay Farley, BGM Chaplain, led in worship focusing on I Peter 2:5: “You also as living stones are being built up as a spiritual house to be a holy priesthood, offering spiritual sacrifices acceptable to God through Jesus Christ.” Using the symbolism of stones building up a foundation, directors were invited to bring one of

the stones placed on the plenary tables to the front after offering a prayer of blessing over ABC using the word written on each stone (“blessing”, “love,” “focus,” “gratitude,” “wisdom,” “strength,” etc.).

BGM 283 CONSENT AGENDA

President Fackenthal presented the consent agenda. A motion was made, seconded, and it was

BGM 284 ELECTIONS, NOMINATIONS AND APPOINTMENTS

Election of General Directors

Up to five (5) General Directors are elected, by the Members giving due regard to geographic, racial, ethnic and gender diversity and expertise on the Board of General Ministries, the National Boards and within the Constituencies of ABCUSA.

A motion was made, seconded and it was

VOTED: At the recommendation of the BGM Executive Committee, to elect Zina Jacque, ABC of Metro Chicago, as General Director (class of 2019) to the Board of General Ministries.

A motion was made, seconded and it was

VOTED: At the recommendation of the BGM Executive Committee, to elect Thomas Ross, Jr., ABC of Metro New York, as a General Director (class of 2019) to the Board of General Ministries.

President’s Nominations and Appointments

President Judy Fackenthal presented the following nominations:

BGM 285 ELECTION OF NATIONAL SECRETARIES OF ABCUSA

Election of the Executive Directors of ABHMS and IM as National Secretaries of ABCUSA

The ABC Bylaws, Article XV, Section 1: The Executive Director of the corporation managed by each National Board, elected or appointed by such National Board in accordance with Article XIII, Section 2 of these Bylaws, shall be elected by the Board of General Ministries as a National Secretary of ABCUSA to serve for a term which is concurrent with such person's term as such Executive Director; provided that the General Secretary serves as a member of the advisory search committee of such corporation which recommends the appointment of such Executive Director and the corporation remains a party to the Covenant of Relationships.

A motion was made, seconded and it was

VOTED: To elect Rev. Dr. Jeffrey Haggray, Executive Director of American Baptist Home Mission Societies, as a National Secretary of ABCUSA to serve for a term which is concurrent with his term as Executive Director.

A motion was made, seconded and it was

VOTED: To elect Rev. Sharon T. Koh, Executive Director of International Ministries, ABC, as a National Secretary of ABCUSA to serve for a term which is concurrent with her term as Executive Director, effective August 1.

BGM 286

REPORT OF THE INTERIM GENERAL SECRETARY

Interim General Secretary Susan Gillies, who was attending her first meeting of the full Board of General Ministries, affirmed the work accomplished at the BGM Retreat, noting that this is a long journey we are a part of, and expressing the importance of taking small strides forward so we do not fall back.

In her report to the board, Susan addressed the recent shooting in Orlando, Florida, sharing with BGM the press release which was just posted this afternoon on the ABCUSA-Office of the General Secretary website, extending sympathy to families and friends of the victims and addressing American Baptist brothers and sisters who are part of the LGBTQ community with this statement: “....never mistake our debates and disagreements with the depth of our love for you as part of our family. To the rest of the ABC family my message is, even in the midst of profound disagreement; let us love as Christ loved.” Susan reported that a press release addressing gun violence and racism will also soon be posted.

Susan ended her report by celebrating the fact that at its June 2017 meeting, the name of the proposed new General Secretary will come to BGM for vote. Susan also submitted to BGM a written report of update.

BGM 287

BGM OFFERING

Judy Fackenthal reported that the BGM Executive Committee voted to direct the BGM offering to be collected on Saturday, June 18, 2016 to persons working with families of the victims of the Orlando massacre. She encouraged BGM directors and staff to prayerfully consider “what the Lord prompts you to give to bring support to those in need at this time.”

BGM 288

EXECUTIVE SESSION

President Fackenthal recessed the meeting of the Board of General Ministries to meet in Executive Session, without staff present, to discuss the General Secretary Search—job description, process, recruitment firms and timeline. Interim General Secretary Susan Gillies was invited to remain for the Executive Session due to her work and reflection on the search process.

President Fackenthal reconvened the meeting of the BGM.

As a result of the November 2015 Mission Table, ABC churches, regions and national organizations were encouraged to focus on one or more of 7 priorities (Next Generation of Leaders, Violence, Discipleship, Poverty, Gospel in a Rapidly Changing Society, Women in Ministry, and Alternative Models for Pastoral Ministry) to engage these priorities and to continue to champion ministries associated with these priorities. BGM will be focusing on “The Gospel in a Rapidly Changing Society.” The BGM Executive Committee decided that at each June and November BGM meeting, Action Groups will meet for one session, dedicating the remaining time when Action Groups would normally meet for a second session, to hear from a variety of leaders involved in proclaiming the gospel in the midst of change. Speakers will engage BGM in discussions that provide a sense of how God is at work in the world in new and innovative ways. At the November 2016 meeting, Duh Kam will address the issue of refugee resettlement.

Judy also reported that the Executive Committee recognizes that due to both *Transformed by the Spirit* and the denominational focus on the 7 priorities, congregational renewal is being championed by ABC partner organizations in new and various ways. Because of this, the Executive Committee recommends that BGM’s Renewing Congregations Action Group be discontinued, with members joining one of the remaining groups. The Executive Committee commends the work of Wesley Roberts and Jeff Woods and members of the Congregational Renewal Action Group, and Judy expressed gratitude on behalf of BGM for their good work.

There was time for questions and discussion. It was noted that the website prepared for Mission Summit conversations, www.missionsummitconversations.com, functions as an online interactive forum to share ministry information and to build a sense of community among American Baptists. Case statements for each of the 7 priorities are included on the site. The ABCUSA-Office of the General Secretary website also carries a link to the Mission Summit website.

BGM 290**UNITED MISSION ADVERTISING**

BGM received, prior to the meeting, a written report from the United Mission Advertising (UM AD) Team regarding its work on the “United Mission is the Vehicle” emphasis to raise the ABC family’s awareness and enthusiasm for United Mission. The first phase included a pilot project involving three regions, conducted from late September to December 2015. UM AD met on April 18, 2016 to begin planning the 2017 campaign. Tasha Wilson, a member of the Team, invited BGM directors to reach out to her or to Leo Thorne, with any questions about the written report or about the work of the UM AD Team.

BGM 291**REPORT OF CHANGED RELATIONSHIPS**

Josue Gómez-Menendez, chair of the Credentials and Caucus Committee, presented the Report of Changed Relationships of Local Churches. Following a time for discussion and questions, a motion was made, seconded, and it was

VOTED: To recognize the Report of Changed Relationships of Local Churches (document 1205.1:6/16) dated November 5, 2015 through June 3, 2016.

BGM 292**BGM EXECUTIVE COMMITTEE**

President Fackenthal reported on the March 10-12, 2016 BGM Executive Committee meeting at Camp Verde, AZ, hosted by Rainbow Acres, one of ABCUSA’s Associated Ministry Organizations. She also reported on actions taken at the Executive Committee’s meeting on Wednesday, June 15, at Green Lake.

Minutes from both meetings are posted on the BGM document page and filed in the General Secretary's office.

BGM 293 BIENNIAL MISSION SUMMIT

President Fackenthal reported on Biennial Mission Summit planning and the 2017 Orientation to American Baptist Life (OTABL), to be held for the first time in tandem with the BMS in Portland. She expressed her excitement for the wonderful way in which ABC can bring pastors new to ABC and American Baptist seminarians to ABC life through such an organic participatory experience.

The Biennial Mission Summit Planning Team met on March 29-31, 2016 in Portland, OR. During this meeting the BMSPT toured the Oregon Convention Center and narrowed down the Biennial space required by ABC. The planning team is in the process of determining plenary speakers and working on the BMS website, which will provide access to online registration. The BMSPT will be encouraging people to consider planning their vacation in tandem with the biennial.

Judy also noted, with great anticipation, the hope of being able to introduce the new General Secretary at this 2017 family celebration.

BGM 294 RECESS OF BGM CONVENING OF THE ABHS CORPORATE MEETING

The Board of General Ministries recessed and reconvened as the corporate members of the American Baptist Historical Society. Garth Brokaw, president of the ABHS Board, called the meeting to order and he and ABHS Executive Director Deborah Van Broekhoven reported on the work of the Historical Society. ABHS routinely holds its corporate meeting in November each year, but due to calling a new executive director, the meeting was convened in June to take action on a proposed candidate for the executive director position. Minutes will be distributed following this meeting and a copy attached to the official minutes filed in the General Secretary's office.

BGM 295 REPORT OF ABCUSA NOMINATING COMMITTEE

President Fackenthal reported that the ABCUSA Nominating Committee met yesterday morning, June 16. The agenda included discussion related to the process for selecting officers for the 2018-2019 Biennium (president category to be lay male; vice president category to be lay female). A section on the ABCUSA website will be created for the General Secretary's search process.

The Nominating Committee will also be filling a vacancy on BGM, due to Janice Bell's move from New York to Florida. Judy shared gratitude for Janice's work.

BGM 296 PUBLIC WITNESS STATEMENTS

Past President Don Ng reported that the BGM Executive Committee has been in conversation during recent meetings related to BGM's operating under the new ABCUSA Bylaws and Standing Rules and the apparent need now for proposed revisions to some of the Standing Rules. ABCUSA has also experienced two Biennial Mission Summits without the opportunity for delegates to voice Public Witness Statements, as was formerly provided for with the Statements of Concern process under the old Bylaws. Don asked the board to consider this issue and to pray about a possible way to move forward.

As one possible way forward, Don proposed that BGM identify a place in Baptist life where the new normal be called "Baptists Talk," a place where Baptists can come to talk together without being polarized, to begin

to live into God's reign in heaven as we conduct heart to heart conversations without schism, taking the "hallway conversations" back into meeting rooms and talking with other Baptist brothers and sisters, not just within our own circles. In light of this conversation, Don proposed the formation of a taskforce, which would come for board approval.

Time was provided for questions and further discussion. A question was raised about whether such a taskforce might be formed between now and the November BGM meeting. It was agreed that this may need to be a slower process, with formation of such a taskforce following the meeting in Portland.

A motion was made by Janice Bell, seconded by Elmore Warren, and it was

VOTED: That BGM create a Taskforce on Baptist Talk

Further discussion culminated with consideration of this new group being named as a Commission, which could include people outside BGM. Interim General Secretary Susan Gillies spoke to the issue of funding. The first motion was recalled. A motion was made by Janice Bell, seconded by Elmore Warren and it was

VOTED: To establish a commission on "Baptist Talk" to discuss meaty issues.

It was noted that the current mission table conversations can be part of this. President Judy Fackenthal will have responsibility for the formation of this commission.

BGM 297 WORLD RELIEF COMMITTEE

Shirley Fair, BGM director and Chair of the World Relief Committee, shared an update of the committee's work. A full written report, including a financial report, was also posted on the BGM document page prior to this meeting for review and is attached to the minutes.

As part of her report, Shirley encouraged BGM directors to keep their respective regions engaged with One Great Hour of Sharing. The theme of the 2016 OGHS materials is the displaced people of our world. Globally, as of June 2015, one in every 122 human beings is either a refugee, is internally displaced, or is seeking asylum. If these groups of displaced persons were categorized as a country, that country would rank as the world's 24th largest.

Gifts to One Great Hour of Sharing are helping in tangible ways, currently aiding Syrian and Middle East refugees in Lebanon, Hungary, Croatia, Serbia, and Greece; the small percentage of refugees currently being accepted for resettlement in the U.S and the internally displaced in South Sudan, even as they brace for the outbreak of more civil conflict. And more needs will continue to reveal themselves in the coming years.

2016 OGHS promotional materials were sent to all churches the first week of April and other materials, including a Planning and Resource Guide, poster, bulletin inserts, offering envelopes and refugee tent-shaped coin boxes, were mailed to the 2,294 American Baptist churches that have requested them.

BGM 298 BGM ACTION GROUPS

President Fackenthal reviewed the schedule for the evening and recessed the meeting of the full Board of General Ministries. Retirement Celebrations; Honoring Deborah Van Broekhoven and Leo S. Thorne; 8:00 p.m. – 9:00 p.m.

BGM directors, staff and other guests gathered in the Tower Dining Room to celebrate the faithful years of ministry of Dr. Deborah Van Broekhoven, Executive Director of the American Baptist Historical Society, who served in this role since September 1, 1998, and Rev. Dr. Leo S. Thorne, Associate General Secretary for Mission Resource Development, ABCUSA, who served in this role since January 12, 2006. There was a special program, singing, prayer and the presentation of gifts. Both will conclude their service on August 31, 2016.

BGM 300

RECONVENING/SHARING OF CELEBRATIONS & CONCERNS

ABC Vice President Josue Gómez-Menendez reconvened the meeting of the Board of General Ministries. He led in prayer and the lighting of the Christ Candle.

The Board shared in a time of celebrations and concerns, after which BGM Chaplain Kay Farley led in prayer.

BGM 301

REPORT OF THE BUDGET REVIEW OFFICER

YTD Financial Report: Budget Review Officer Paul Higgins reported that the Year-to-Date financials through April 2016 show an approximate 1% surplus with ABC breaking even or doing slightly better. While there was a financial loss late last year, it was primarily due to investment loss.

ABCUSA Audit: The report of independent certified public accountants, Tait, Weller & Baker LLP, stated that ABCUSA's audit was "impeccably clean." The auditors reported that staff, while being tasked with a 4 - 6% reduction each year, have done an excellent job of managing expenses.

Based on the recommendation of the BGM Finance Committee it was

VOTED: To accept, as recommended by the BGM Finance Committee, the Auditor's Report on the 2015 ABCUSA Audited Financial Statements for the years ended December 31, 2015 and 2014.

Grants from the Mission Initiative Fund: The ABCUSA Finance Committee reviewed requests for grants from the Mission Initiative Fund. One request was for a three-year grant to help provide seed money to form an ABC Creation Justice Network. The creation of this network would foster dialogue within the ABC family in terms of our responsibility towards God's creation. It would also enable ABC to cooperate more effectively with ecumenical and interfaith partners such as Creation Justice Ministries, an ecumenical eco-justice organization affiliated with the National Council of Churches. The ABCUSA Finance Committee approved \$20,000 in funding for 2016-2017 (September-August). Further funding will be considered after receiving a report from the ABC Creation Justice Network.

Building Update: A Mission Center Building Update document was distributed. In summarizing steps which have been taken, Alan Musoke explained that 15 potential developers were invited to participate in an exploration of a "joint venture" process. Of those invited, nine submitted plans; of those nine, three were invited to submit Best And Final Offers (BAFO). The deadline to receive BAFO responses is July 9. It is anticipated that the BAFOs will include various combinations of retail and service-oriented structures. In response to a question, Alan stated that while there is a desire to maximize the value of the property there is continued concern over the type of businesses which would be located on the property. He noted that zoning has been changed so that almost any plan could be followed.

Mission Center Property Taxes: Alan reported that both the Township of Upper Merion and the School District agreed to a settlement of 588 Associates' tax appeal, agreeing upon a 41.26% tax-exempt percentage, with the remaining percentage considered taxable. He also reported that Palmer Seminary is vacating their leased space in June 2016. A question was asked about the possibility of leasing the vacated space. Alan responded that it would be difficult to find long-term tenants due to the disposition of the building. He also noted that the loss of rental income from Palmer has already been taken into account.

BGM 302

ACTION GROUP REPORTS

Action groups were given time to highlight items from their written reports and from their meetings earlier.

Finance Committee Action Group: Paul Higgins reported that the draw rate from our 2 endowments has been reduced from 5% to 4.5% and may need to be reduced further. He spoke briefly about region audits which the Finance Committee reviews. It is of concern that some regions do not submit audits and it would seem that some regions do not have any review of their financials. The mission receipt forms which have been revised were reviewed.

Beloved Community Action Group: Camille Brown thanked the president and the Executive Committee for including the Beloved Community group members in the retreat planning process. She suggested that the small group process be continued by taking an agenda item and then having a small group deal with it.

ABC Identity Action Group: Jonathan Malone spoke about the 2 logos and the question of which a church should use. Susan suggested that we do not rush into making a decision but consider again in November. Our organization is the harmonizer and we desire to bring unity to the denomination and to help the program boards understand our importance.

Renewing Congregations Action Group: Wesley Roberts noted that this was the last meeting of the action group and, as such, time was spent in reflecting on what has been accomplished. The group has considered the life cycle of congregations, church renewal strategies, research on church growth, reviewed Transformed by the Spirit Resources, and identified stories of renewal. Wesley spoke about his concern over the loss of congregations and the need to keep this in our thinking.

Committee on Christian Unity and Interfaith Relations: June Totten reminded the board of the Luke Mowbray Award which is presented at the Biennial. June asked directors to be thinking of nominees. She also spoke about a third Baptist/Muslim dialogue which will probably be a retreat at Green Lake. Participants will be invited by the taskforce to come “2 by 2”—one Baptist and one Muslim. The focus will be on young people (40 years and younger).

BGM 303 WRITTEN REPORTS

Josue noted that a number of written reports were transmitted prior to the meeting as a means of sharing information and updates and time was provided for comment and questions relative to these reports.

President’s Report: Judy spoke about her desire to be available to directors and noted that not all ideas shared will be instituted. She spoke about the changes which have occurred as the move has been made from a huge conglomerate board & process to that of a working board. In reference to the General Secretary Search Committee she spoke about the way in which an orchestra tunes its instruments before a performance. After each individual musician comes onto the stage the first chair violinist, the concert master, comes and everyone tunes up. After the tuning is complete then the conductor comes onto the stage. She likened the General Secretary to the concert master with God being the conductor. The concert master makes sure the harmony, which at times is lush and rich and at other times dissonant, is there. Judy prays for the search to lead to the person who can be the “harmonizer.” As one way of strengthening relationships within the American Baptist family, Judy, along with Susan, will be returning to Green Lake for the World Mission Conference.

In answer to a question about sharing the telephone numbers of board directors, Judy asked that directors email Marilyn Tyson with the number that can be posted for them. This list of numbers will be posted on the BGM page on the ABCUSA website, which is password protected.

Transformed by the Spirit (TbyS): Jeff Woods reported that the Journey Team is working to improve the TbyS process by involving the pastor to a greater extent. Work in contextualizing the resource to specific geographic areas, to fit the culture of an area, is also being done.

Ken Marsenburg noted that, since the \$800,000 goal for TbyS, has been surpassed, the goal has been raised to 1.2 million. He noted that the Greek for “God loves a cheerful giver” might be rendered as “God loves a hilarious giver.” He challenged the Board to lead by example.

BGM 304 SIGNING OF THE AMO COVENANT: ABCUSA/KACHIN BAPTIST CHURCHES USA

President Judy Fackenthal welcomed Mr. Zau Hkawng Dure, General Secretary of the Kachin Baptist Churches USA, Rev. Dr. Maw San Awng Jum, Associate General Secretary and Ms. Nang Doi Lahpai, President, and several other KBCUSA guests who were present at this meeting of the BGM

At the recommendation of the BGM Executive Committee it was

VOTED: To approve the Kachin Baptist Churches USA as Associated Ministry Organizations (AMOs) with ABCUSA.

Subsequent to this vote, there was a formal signing of a covenant agreement.

Rev. Judy Fackenthal, Mr. Josue Gómez-Mendendez and Dr. Susan E. Gillies signed the covenant on behalf of ABCUSA; Mr. Zau Hkawng Dure, Rev. Dr. Maw San Awng Jum and Ms. Nang Doi Lahpai signed the covenant on behalf of the Kachin Baptist Churches USA.

Dr. Jum and Mrs. Nang Doi Lahpai shared some remarks and presented a wooden symbol of the Kachin as a gift to ABC. There was a time for picture taking as a means of commemoration of the occasion.

BGM 305 BGM OFFERING AND CLOSING WORSHIP

Rev. Bill Frederickson read Numbers 17:1-9 as scripture for worship. Stephanie Commandest sang “Precious Lord, Take My Hand.”

As part of worship, an offering (\$1,000) was collected for persons ministering to the families of victims of the June 12, 2016 massacre in Orlando, Florida.

BGM Chaplain, Rev. Kay Farley, led the Board in prayer circles which encompassed members of the General Secretary’s Search Committee, members of the previous Search Committee, BGM directors and staff. Kay led the prayer which had been prayed in unison at the beginning of the Board retreat and then all joined in reciting the Lord’s Prayer.

BGM 306 ADJOURNING

President Fackenthal adjourned the meeting of the Board of General Ministries.

A Buffet Lunch was served in the Bauer Dining Room for those who did not have to rush to meet a shuttle to the airport. Boxes lunches were provided for others.
