**BGM EC 484                      INVESTMENT POLICY**

The purpose of the Investment Policy is to guide the American Baptist Churches USA Board of General Ministries, the BGM Finance Committee, the ABCUSA Treasurer's Office and any Investment Suppliers in effectively managing, monitoring and evaluating the investment of funds held by the Corporation not including program-related assets. This proposed policy will be added to the agenda of the November BGM Meeting for approval.

**BGM EC 485                    BUILDING ISSUES**

Lee Spitzer showed the diagram of the office layout where OGS and its staff will be in the new building. OGS offices will be centrally located at the main entrance. There will be a shared copier room for OGS and ABHMS. Lee explained that the ABCUSA computer center has been added to the space. The Traffic Department will not be included in the new building.

A formal letter to the ABHMS Board from the BGM Board will be sent with an offer to begin conversation about co-ownership of the 1075 property.

Alan Musoke updated the committee on the current status of the joint venture in which PPG will have 15 acres. The other parcel is 8 acres and no partner has been identified yet.

**BGM EC 486                    FRESH EXPRESSIONS**

Lee Spitzer introduced Fresh Expressions as an integral aspect of his hopes for *Transformed by the Spirit*. Fresh Expressions is an innovative church planting and ministry creation international movement which originated in the United Kingdom's Church of England. The Executive Committee encourages Lee to recommend Fresh Expressions as a congregational resource. but chose not to officially endorse Fresh Expressions.

**BGM EC 489                    BIENNIAL LOCATION PROPOSALS (CONT.)**

The Executive Committee wants to direct staff to find locations, preferably on the East Coast and including resort type cities by November 15. The rotation list of regions for upcoming biennials should be shared with OTACP: East coast, Puerto Rico, Mid- west, and West Coast. Allowing for resort convention center hotels give more options. The Executive Committee wants two viable choices to select from. Josue Gomez strongly suggests finding a place in northeast and going to Puerto Rico for the biennial in 2021.

**BGM EC 490                    REPORT OF BUDGET REVIEW OFFICER (See Report attached)**

### Overall

Overall the year-to-date financials show a net loss of (\$247K) primarily due to Representative Process, and the Development Office.

Net revenue compared to last year is down (\$211K). The primary reason for the decrease in revenue is ABCUSA Departments which had a decrease of (\$188K). Net revenue is determined by subtracting the Biennial from this year and any activity for the Biennial last year.

### Development Office

The Development office had a loss of (\$154K). Revenues realized by this department flow through other departments.

### Women in Ministry

Revenue is up \$26K. This increase is 25% above last year.

### United Mission

Total UM is \$4,292,476. This is a decrease of (\$188,649) from the prior year. This represents a reduction of (4.21%).

## **BGM EC 492                    VISION OF THE GENERAL SECRETARY**

Lee reviewed the “5 Star Structure:” Pastoral Mission, Mission Communication, Conference and Planning, Development, and Administration and Finance. All five stars work together. Staff changes would include Tina Turner becoming the United Mission Coordinator and Bridget Lipin would be working in Communications with IT. In terms of affording the new position for the second Assistant General Secretary, Marilyn Tyson’s position will not be filled after she retires. The reason for two Assistant General Secretary positions is to show that ABCUSA cares about pastors and churches. With additional staff, OGS will be able to support regions, offer creative strategies and helpful resources, and provide greater diversity of assistance. Lee asks that the BGM Board be 100% behind what the Office of the General Secretary (OGS) is doing. In order for OGS to be successful – the board needs to part of the solution.

## **BGM EC 493                    NATIONAL INSTITUTE FOR CIVIL DISCOURSE (NICD)**

NICD is a non-profit, non-partisan institute based at the University of Arizona that is dedicated to addressing incivility and political dysfunction in American democracy. Lee Spitzer wants to join the movement to publicly endorse the Initiative to Revive Civility, to share information about the initiative with members of the denomination, and to encourage interested members and churches to be involved in community conversations to promote civility and respect. Possible guest speaker on this could be brought to the BGM November meeting to share more about NICD.

**BGM EC 494                    UNITED MISSION (CONT.)**

Give Lee and new Assistant General Secretaries some grace time to say that United Mission is for the whole family and then review again in 2018. The BGM Executive Committee gives permission to Paul Higgins to take a \$20,000 adjustment proposal to the ABCUSA finance committee. Empower the General Secretary to forewarn the NEC of the shift in United Mission funding allocations after Finance committee comes up with the final decision.

**BGM EC 495                    UNITED STATES HOLOCAUST MEMORIAL MUSEUM (USHMM)**

The USHMM provides for the documentation, study, and interpretation of Holocaust history. It is dedicated to helping leaders and citizens of the world confront hatred, prevent genocide, promote human dignity, and strengthen democracy. USHMM has offered to provide free specialized training to ABCUSA clergy who wish to help their congregations understand the Holocaust, foster positive ecumenical relations, oppose prejudice (such as anti-Semitism and Islamophobia), and fight for human rights. The proposal involves a 2-3 days of workshops for groups of 20-24 clergy and leaders. The DC Baptist Convention has offered to co-host an additional day for ministry discussions in light of their unique setting. The hope is to hold the first retreat in October or November 2018. ABHMS has continuing education funds that could assist with the costs. One possibility would be to include the National Museum of African American History and Culture as part of the possible event with DC Baptist Convention.

Lee Spitzer has been in conversation with the BGM's Creation Justice Network; as well as, in dialogue with Ryan Burge regarding statistics of where American Baptists are in relation to the issues of the environment.
