Grant funds may not be used to fund staff positions or stipends, rainy day funds, church benevolent funds, regular ongoing church operating expenses (i.e. utilities, insurance), repairs, or for capital improvements or repairs to facilities. Grant awards will be sent to the ABC church that is applying for the grant; checks will not be made payable to an individual or ministry.

When determining Grants awards, the following criteria will be considered: whether the church is in good standing within the region; whether the church contributes to United Mission; number of and amounts of previous Matthew 25 Grants received; sustainability of ministry beyond Matthew 25 Grant funding; description of ministry and needs addressed by funding; and the detailed budget submitted along with this application.

Checks will be made payable to the ABC church. Checks will not be made to an individual or ministry.

SACKS OF LOVE PROGRAM SUMMARY

The Sacks of Love Program is designed to assist with relieving hunger among at-risk students. We started the Sacks of Love Program in January 2014. Over the years, we have increased the number of students from 20 students at one school to 60 students at three schools. The Foundation provides bags of nutritious, non-perishable food for 60 students at three schools to carry home on the weekends during the school year. The food equates to approximately 15,000 meals a school year. Christmas baskets are provided to families of the 60 students served by the foundation. The Christmas baskets contain frozen turkey, fresh collard greens, and non-perishable food such as rice and beans.

The \$4,000 requested will be to purchase food for 20 students at Alcorn Middle School. Alcorn Middle School is a public school located in Columbia, South Carolina. Over 90% of the students qualify for free and reduced lunch. The students will receive bags of nutritious, nonperishable food to carry home and consume on the weekend during the school year. Ensuring that students are nourished during the weekends, increases the likelihood that they will study, complete assignments, and be better prepared to learn upon returning to school from the weekend.

To quote Antwon Sutton, a former principal at Alcorn, "The Sacks of Love Program has been a tremendous success for our students. There are so many students who are not able to partake of nutritious meals on the weekends. Those who receive meals through the program excitedly await the meals on Fridays when they are distributed. Research states that children who eat balanced meals regularly tend to perform better academically and socially. The Sacks of Love Program supports that research heavily."
