BGM EC 832 CALL TO ORDER

ABCUSA President Jim Wolfe called the meeting to order.

BGM EC 833 CONSENT AGENDA

BGM EC 834 REPORT FROM THE ABCUSA PRESIDENT

ABCUSA President Jim Wolfe shared highlights of his report since last meeting in March in Orlando, FL, which included an update on the General Secretary Search Committee. BGM EC 835 REPORT FROM THE ABCUSA GENERAL SECRETARY

ABCUSA General Secretary Jeff Woods shared that we are entering the final stages of the strategic intentional interim period. This has been a period of clarifying the role of the Office of the General Secretary, transforming the culture of the office, renewing staff morale, and achieving milestones made possible by people working together across regional and national boundaries.

On December 23, 2022, President Biden signed the Burma Act Bill into legislation as a part of the National Defense Authorization Act. Jeff participated in a New Year's Day Service with the leaders of the National Unity Government of Myanmar. The Acting President of Myanmar, Duwa Lashi La, said that this is the greatest gift that one country can give to another country. This accomplishment, along with several other ministry updates, is provided in the "Report from the ABCUSA General Secretary."

BGM EC 836 REPORT OF THE BUDGET REVIEW OFFICER

Budget Review Officer Paul Higgins gave a brief overview of the 2022 Audited Financial Statement of the independent certified public accountants, Tait, Weller & Baker LLP.

Paul Higgins referred to the financial report prepared by Alan Musoke, highlighted in the year-to-date financial report for the year ending April 30, 2023 and included in the written report prepared by Alan Musoke, Associate General Secretary for Finance/CFO/Treasurer.
